

**AMENDMENT TO BOARD OF SUPERVISORS

This Amendment to BOS Agreement No. 22-020 is entered into this       day of       , 2022, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **A&A Health Services, LLC.**, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 22-020 was entered into on November 24, 2021; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the amount in BOS Agreement No. 22-020, from \$100,000 to \$159,000; and

WHEREAS, CONTRACTOR will continue to provide residential care services.

NOW, THEREFORE, we agree as follows:

1. The amount set out in BOS Agreement No. 22-020 is hereby increased from \$100,000 to \$159,000.

All other terms and conditions of BOS Agreement No. 22-020 shall remain in full force and effect.
