## **RESOLUTION NO. 22-141**

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS SITTING AS THE MENDOCINO COUNTY AIR QUALITY MANAGEMENT DISTRICT (MCAQMD) BOARD RATIFYINGTHE GRANT AGREEMENT FOR MCAQMD TO ACCEPT THE STATE AIR RESOURCES BOARD EMISSIONS INVENTORY GRANT ROUND 4 (G20-EIDG-15) FOR UPDATING AND REPORTING FACILITY EMISSIONS DATA (AB 197) AND RATIFYING THE AIR POLLUTION CONTROL OFFICER'S EXECUTION AND SUBMISSION OF THE GRANT AGREEMENT ON BEHALF OF THE MCAQMD

WHEREAS, in 2016, the Legislature passed, and the Governor signed Assembly Bill 197 (AB 197), requiring the state Air Resources Board to make available, and update annually, on its website the emissions of greenhouse gases, criteria pollutants and toxic air contaminants for each stationary source that reports to the state board and local air districts; and

WHEREAS, the Mendocino County Air Quality Management District has within its jurisdiction, stationary sources of criteria pollutants and toxic air contaminants; and

WHEREAS, the Mendocino County Air Quality Management District is required to calculate and report emissions of criteria pollutants and toxic air contaminants from the stationary sources within its jurisdiction to the Air Resources Board; and

WHEREAS, ARB has funding available through direct grants to local air districts to cover district costs associated with calculation and reporting of emissions of criteria pollutants and toxic air contaminants from the stationary sources within its jurisdiction; and

WHEREAS, ARB allocated approximately \$8,583 to MCAQMD for support of MCAQMD'S activities associated with the AB 197 Emissions Inventory Program (G20-EIDG-15) for the term June 1, 2021 through May 1, 2022.

WHEREAS, MCAQMD has already signed and submitted the Agreement to the State Air Resources Board as required to secure funds.

WHEREAS, ARB has agreed to accept the signed Agreement pending Board Resolution accepting the funds, authorizing the execution of the grant agreement and agreeing to administer the funds consistent with the AB 197 Emissions Inventory Program Grant Agreement Provisions and the general terms and conditions of the agreement associated with the grant.

NOW THEREFORE BE IT RESOLVED, that the Mendocino County Board of Supervisors sitting as the Air Quality Management District Board hereby

- 1. Accepts the Air Resources Board (ARB) AB 197 Emissions Inventory Grant (G20-EIDG-15), and
- Authorizes MCAQMD to accept AB 197 Emissions Inventory Grant funds, agrees to administer the funds consistent with the 197 Emissions Inventory Program Grant Agreement Provisions and the general terms and conditions of the Agreement associated with the grant; and
- Ratifies the Air Pollution Control Officer's execution and submission of the Agreement to ARB.
