

**AMENDMENT TO COUNTY OF MENDOCINO
PURCHASING AGENT AGREEMENT NO. 22-29, SS-21-091**

This Amendment to Agreement No. PA 22-29, SS-21-091 is entered into this 7th day of June, 2022, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **City of Fort Bragg**, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PA 22-29, SS-21-091 was entered into on November 18, 2021; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in Agreement No. PA 22-29, SS-21-091, from March 31, 2022 to April 30, 2022; and

WHEREAS, CONTRACTOR will continue to provide emergency shelter services to persons experiencing homelessness in the Mendocino Coastal Area during extreme weather events.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in Agreement No. PA 22-29, SS-21-091 is hereby extended from March 31, 2022 to April 30, 2022.

All other terms and conditions of Agreement No. PA 22-29, SS-21-091 shall remain in full force and effect.
