

**RESOLUTION NO. 23-087**

**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 230008 TO REMOVE AND REPLACE 450 FEET OF GUARDRAIL ON MOUNTAIN VIEW ROAD, COUNTY ROAD 510, AT MILEPOST 2.70, AT AN ESTIMATED COST OF \$104,230 (POINT ARENA AREA)**

WHEREAS, the Mendocino County Department of Transportation (DOT) is desirous of removing and replacing damaged guardrail, and end treatments per the current Caltrans standards and specifications on the following County Road:

- Mountain View Road, County Road (CR) 510, at milepost (M.P.) 2.70; and

WHEREAS, construction costs are estimated to be some \$104,230 for 450 feet of guardrail replacement, with 162.5 feet of the guardrail (which was destroyed by a private entity) anticipated to be paid for by the private entity's insurance at an estimated cost of \$57,443.75, and 287.5 feet of guardrail and end treatments replaced using funds from the Road Fund at an estimated cost of \$46,786.25; and

WHEREAS, funding to accommodate construction costs is available in Budget Unit 3010 for Fiscal Year (FY) 2023/24; and

WHEREAS, under Section 20395 of the California Public Contract Code, the Board of Supervisors may authorize the Director of Transportation to execute contract change orders subject to certain cost limitations; and

WHEREAS, by Resolution 07-008, the Board of Supervisors authorized the Director of Transportation to execute changes to any DOT contract that exceeds \$250,000 by up to \$25,000, plus 5% of the amount of the original contract costs adds up to \$250,000, and in no event shall any change or alteration exceed \$150,000; and

WHEREAS, the Director of Transportation recommends and requests authorization to proceed with the advertisement and award of DOT Contract No. 230008.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

1. Authorizes the Director of Transportation to sign the Notice to Bidders inviting bids for DOT Contract No. 230008 for the removal and replacement of 450 feet of guardrail and end treatments on:
  - a. Mountain View Road, CR 510, at M.P. 2.70; and

2. Authorizes and directs the Director of Transportation to award DOT Contract No. 220008, upon confirmation of an appropriate low bidder and acceptable contract documents by County Counsel and Risk Management, and report the results to the Board through the applicable Chief Executive Officer's Report.
