

**THIRD AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 21-005**

This Third Amendment to BOS Agreement No. 21-005 is entered into this 9th day of May, 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Abbott & Kindermann, Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 21-005 was entered into on January 4, 2021; and

WHEREAS, BOS Agreement No. 21-005-A1 was entered into on May 4, 2021 extending the termination date from June 30, 2021 to June 30, 2022; and

WHEREAS, BOS Agreement No. 21-005-A2 was entered into on May 3, 2022 extending the termination date from June 30, 2022 to June 30, 2023 and increasing the total amount from \$10,000 to \$60,000; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Abbott & Kindermann, Inc., this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. 21-005, from June 30, 2023 to June 30, 2024.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. 21-005 will be extended from June 30, 2023 to June 30, 2024; and

All other terms and conditions of BOS Agreement No. 21-005 shall remain in full force and effect.
