

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 22-218**

This Amendment to BOS Agreement No. 22-218 is entered into this 9th day of May , 2023 , by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and COLANTUONO, HIGHSMITH & WHATLEY, PC., hereinafter referred to as "CONTRACTOR".
