RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD THREE DEPARTMENT OF TRANSPORTATION CONTRACTS TO CONSTRUCT 2023 STORM DAMAGE PERMANENT REPAIRS ON MOUNTAIN VIEW ROAD, COUNTY ROAD 510, AT MILEPOST 1.69, AND MENDOCINO PASS ROAD, COUNTY ROAD 338, AT MILEPOSTS 15.50 AND 16.75, AT AN ESTIMATED COST OF \$2,110,313 (COUNTYWIDE)

WHEREAS, the Mendocino County Department of Transportation (DOT) is desirous of performing storm damage permanent repairs utilizing contractor forces on Mountain View Road, County Road (CR) 510, at mileposts (M.P.) 1.69, and Mendocino Pass Road, CR 338, at M.P. 15.50 and M.P. 16.75; and

WHEREAS, by Resolution Number (No.) 23-012 (January 10, 2023), the Board of Supervisors declared the existence of a Local Emergency related to the December 2022/January 2023 Winter Storms Event; and

WHEREAS, construction costs for these three DOT projects are currently estimated to be some \$2,110,313 and are anticipated to be 88.53% reimbursable through the Federal Highway Administration (FHWA); and

WHEREAS, funding to accommodate construction costs prior to reimbursement has been budgeted through Budget Unit 3030 for Fiscal Year (FY) 2023/24 and FY 2024/25; and

WHEREAS, under Section 20395 of the California Public Contract Code, the Board of Supervisors may authorize the Director of Transportation to execute contract change orders subject to certain cost limitations; and

WHEREAS, by Resolution 07-008, the Board of Supervisors authorized the Director of Transportation to execute changes to any DOT contract that exceeds \$250,000 by up to \$25,000, plus 5% of the amount of the original contract costs adds up to \$250,000, and in no event shall any change or alteration exceed \$150,000; and

WHEREAS, the Director of Transportation recommends and requests authorization to proceed with the advertisement and award of these three DOT contracts to construct the repair of these storm damaged sites upon receiving the authorization to construct the projects from FHWA.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

| 1. | Authorizes and directs the Director of Transportation to sign the Notice to Bidders, inviting bids for construction of storm damage permanent repairs on the above mentioned road segments, upon receiving the funding authorization from approving agencies to proceed with such action; and |
