RE: ADOPTION OF RESOLUTION AUTHORIZING DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 160103 TO PERFORM TRAFFIC SIGNAL MAINTENANCE ON NORTH STATE STREET, COUNTY ROAD 104, AT THE INTERSECTIONS OF FORD ROAD, COUNTY ROAD 250, KUKI LANE, COUNTY ROAD 250A, WEST LAKE MENDOCINO DRIVE, COUNTY ROAD 227B, AND LAKE MENDOCINO DRIVE, COUNTY ROAD 227B, (UKIAH AREAS)

Honorable Board Members:

Mendocino County Department of Transportation (MCDOT) Contract Number (No.) 160103 will provide video imaging vehicle detection systems on North (N.) State Street (St.), County Road (CR) 104, at the intersections of Ford Road (Rd.), CR 250, and Kuki Lane (Ln.), CR 250A. MCDOT Contract No. 160103 will also provide battery backup systems, light emitting diode (LED) modules for all traffic and pedestrian signal indicators, and retroreflective perimeters on the face of each traffic signal on N. State St., CR 104, at the intersections of Ford Rd., CR 250, Kuki Ln., CR 250A, West (W.) Lake Mendocino Drive (Dr.), CR 227B and Lake Mendocino Dr., CR 227B. This project is estimated to cost about \$136,000 to complete. This project is to be constructed through the use of Road Funds in Budget Unit 3041.

MCDOT intends to advertise for bids and have this project completed this calendar year. MCDOT will prepare construction plans, specifications, estimates and contract documents, advertise and award a County contract, and coordinate the project with the other governmental agencies.

I recommend and request that the Board authorize and direct the Director of Transportation to advertise for construction bids and to award MCDOT contract no. 160103 to perform Traffic Signal Maintenance on N. State St., CR 104, at the intersections of Ford Rd., CR 250, Kuki Ln., CR 250A, W. Lake Mendocino Dr., CR 227B and Lake Mendocino Dr., CR 227B. The total numbers of intersections to be serviced are 4; total numbers of traffic and pedestrian signals to be serviced are 79. If bids are higher than estimated, reductions in the number of intersections will be made; Ford Rd., CR 250, and Kuki Ln., CR 250A, are the base bids.

Department of Transportation staff personnel have prepared a draft Resolution which provides said authorization for the Board's consideration and adoption.
