**CULTIVATION REGULATION** CULTIVATION REGULATION

It is proposed to add a new Chapter 9.30 to the Mendocino County Code regarding Adult Use Marijuana Cultivation Ordinance, and to amend Chapter 9.31 regarding Medical Marijuana Cultivation Regulation. Chapter 9.30 will regulate the personter 9.30 will regulate the personal cultivation of adult use marijuana as legalized by California Proposition 64, by regulating how and where adult use marijuana may be cultivated within the unincorporated area of Mendocino County. Amend-ments to Chapter 9.31 are proposed to complement the regulations imposed by Chapter 9.30 as well as revise how and where Chapter 9.31 is applicable. To the extent practicable, the regulations on cultivation are consistent between Chapters 9.31 and 9.30 and the County's newly adopted Chapter 10A.17.

The proposed ordinance scheduled for adoption on May

2, 2017.
