Local Job Fair:


HHSA Update

HHSA Adult and Aging Services - Elder Abuse Awareness Month

In California, as many as 50,000 cases of elder and dependent adult abuse go unreported every month. To help increase reporting, the Area Agency on Aging (AAA) and the Health and Human Services Agency Adult and Aging Services Division are teaming up with older adult advocates to educate our communities about elder and dependent adult abuse during the month-long KNOW ABUSE REPORT ABUSE campaign in June 2017. In Mendocino County, we receive 900 reports of Elder and Dependent Adult abuse per year.

Elder and dependent adult abuse takes many forms, some more obvious than others. Physical, mental, sexual, and financial abuse, as well as neglect and self-neglect are recognized in state law as forms of elder and dependent adult abuse. Reports for all types of elder and dependent adult abuse are on the rise. Indicators include lack of adequate food, water, changes in personal hygiene, physical injuries, ripped or stained clothing/sheets, signs of coercion/intimidation, unexplained purchases by a caregiver.

Mendocino County HHSA, Adult Protective Services has a 24-hour hotline for reporting abuse of older adults and disabled adults who may be physically or financially abused, neglected, or exploited. The local APS number is 1-877-327-1799.

Little River Airport Update

The Department of Transportation (DOT) has inquired with the Federal Aviation Administration (FAA) about the process to obtain approval to construct hangars and/or vehicle storage buildings at the Little River Airport. The FAA indicates the following requirements for any new buildings/hangars: (1) Be depicted on an FAA-Approved Layout Plan (ALP); (2) Airspace case analysis determinations; and (3) National Environmental Policy Act (NEPA) review. Since the ALP process is expensive (+/- \$75,000-\$100,000), there are two locations where hangars are currently depicted on our ALP as options.

The County's aviation consultant is currently analyzing these two sites under our on-call service contract. DOT has asked for an estimate of what it would cost at each site to build the infrastructure for private hangars, including environmental clearance, pavement design, utilities, etc. The FAA has made it clear that there will not be any funding for this project for quite some time since all safety projects take priority. In order to construct any storage buildings other than hangars, an ALP update would need to take place to include these structures. Additionally, this topic will be added to the agenda to be discussed at the next Little River Airport Advisory Committee meeting.

Water Agency News

The Ukiah Valley Basin Groundwater Sustainability Agency will be holding a public hearing on June 15, 2017, at 1:30 p.m., at the Ukiah Civic Center Council Chambers, 300 Seminary Avenue, Ukiah, CA 95482, to consider a proposed Resolution to become a Groundwater Sustainability Agency (GSA) for the Ukiah Valley Basin, pursuant to the Sustainable Groundwater Management Act (SGMA). Cannabis Update

On June 2, 2017, the Executive Office issued a press release regarding Cannabis Cultivation Program updates. The County has been actively working on streamlining the permitting processing, including activating a Cannabis Information Hotline,

(1-844-421-WEED (9333)). The press release outlines the steps required to submit an application for processing. The press release is attached to this report.

The County of Mendocino has selected SICPA to provide a track and trace system called CalOrigin to support the new Cannabis Program. This system will be used by organizations permitted by the County to operate a cannabis business which cultivates, manufactures, distributes, tests, delivers, and/or dispenses cannabis in the unincorporated areas of the County. The County and SICPA will be holding community outreach workshops on June 14 and 15, 2017, to discuss the new program, training, support and next steps for potential permittees. Animal Shelter Update

Clinic:

The Animal Shelter Clinic performed approximately 150 spay and neuter surgeries in the month of May 2017.

Caravan:

The Mobile Spay and Neuter Caravan performed approximately 120 spay and neuter surgeries in the month of May 2017.

Feel Good Story:

A three to four month old female, Doberman puppy was found at a local park by a concerned citizen with a possible broken front leg and brought to the shelter on May 23, 2017. The puppy, which was named "Cedar," was taken to one of our contracted veterinarian hospitals for x-rays and given an initial evaluation. The broken leg was confirmed. The prognosis for the dog was surgery to amputate or surgery to save the leg.

During her hold time at the Animal Shelter, "Cedar" was cared for by Animal Care Services staff member Lisa Penry, while Sage Mountainfire, the Animal Shelter Supervisor, searched for grants to cover the expensive cost of surgery that was required in order to have Cedar's broken leg medically heeled correctly. Two grants were obtained through the Special Needs Doberman and Decker McKee Doberman Rescue Assistance organizations to cover the cost of the expensive surgery.

"Cedar" had successful surgery on May 27, 2017, and is on her way to full recovery.

Outcome Statistics:

During the month of May, 2017, 43 dogs were adopted, 24 cats were adopted, 55 animals were transferred to rescue organizations and 42 animals were returned to their owners. The live release rate was 87.5%.



COUNTY OF MENDOCINO ANNOUNCES CANNABIS CULTIVATION PROGRAM UPDATES

On May 4, 2017, the County of Mendocino launched the Cannabis Cultivation Program. Since that time, the County has been actively working on streamlining the permitting process. The following steps are required to submit an application for processing:

- Applicants must make an appointment with the Department of Agriculture to submit a cannabis application package, including proof of prior cultivation.
- The Department of Agriculture staff will review the Initial Cannabis Cultivation Application and complete an Initial Application Review Checklist
- Applicants must sign the Initial Application Review Checklist and take it to the Treasurer/Tax Collectors Office to make a payment of a non-refundable application fee
- Applicants must submit proof of payment of the application fee to the Department of Agriculture. Once proof of payment has been verified by the Department of Agriculture, applications will be accepted for processing

Please note that the Treasurer/Tax Collectors office <u>will not</u> receive payment for any cultivation permit application fees without having evidence of the completed and signed Initial Application Review Checklist from the Department of Agriculture.

Also, the County activated a Cannabis Information Hotline (1-844-421-WEED (9333)) for all cannabis related inquires, questions, and/or to be directed to the appropriate department associated with the inquiry. All interested parties will call one number for cannabis related inquiries. This hotline includes options on how to register cannabis complaints, where to apply for permits, where to pay cannabis related taxes, information regarding the building permit process, as well as general information regarding the County's Cannabis Cultivation Program. "Having one central point of contact for cannabis related questions will greatly assist those who are in need of clarification or assistance with the program; we are extremely pleased to be able to offer this service", commented Chief Executive Officer, Carmel J. Angelo.

Please note that permit applications are only being accepted for cultivation sites within zoning districts of the Inland Zoning Code. The current permit program does not address cultivation in the Coastal Zone. No more than two permits may be issued to a person or entity pursuant to section 10A.17.070 (D) of the Mendocino County Medical Cannabis Cultivation Ordinance.
