Not only are there numerous "potholes", there is also a culvert near 10050 West Road that needs to be replaced. The DOT occasionally places gravel over the culvert, however the gravel lasts only a few days before it requires drivers to slow to less than 5 mph to avoid damaging their vehicle. The culvert was damaged more than 6 months ago. Certainly there has been adequate time to make this much needed repair. If replacing the culvert is an issue, at least replace the gravel with paving material.

Therefore, we the undersigned request that the County Board of Supervisors require the County Department of Transportation make the much needed improvements to West Road this summer, while the weather permits. The roads need more than tossing a bit of paving material in the potholes - the roads need to be paved!
