

**AMENDMENT NO. 13 TO FRANCHISE AGREEMENT
BETWEEN THE COUNTY OF MENDOCINO AND USA WASTE OF CALIFORNIA, INC., DBA EMPIRE
WASTE MANAGEMENT FOR SOLID WASTE REFUSE COLLECTION AREA NO. TWO**

This Thirteenth Amendment of the Board Of Supervisors Franchise Agreement ("Agreement") between the County of Mendocino and USA Waste of California, Inc., dba Empire Waste Management is made on this 20 day of June, 2017 by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "County," and USA Waste of California, Inc., dba Empire Waste Management, hereinafter called "Grantee."

WHEREAS, County and Grantee entered into Agreement for the collection, transportation, and disposal of solid waste in Solid Waste Refuse Collection Area No. Two and said Agreement was approved by the Board of Supervisors by Resolution No. 04-074 on May 11, 2004 with an expiration date of June 30, 2011, later amended to be June 30, 2021; and

WHEREAS, County and Grantee have amended the Agreement from time to time to adapt to changing conditions and new information; and

WHEREAS, Sections 14 and 15 of the Franchise Agreement set forth provisions for rate adjustments, and further authorizes the Board of Supervisors and/or the County Administrative Officer (now known as the Chief Executive Officer) to amend pass-through and cost-of-living rate adjustments provided County has received and considered required documentation, and Grantee's rate adjustment calculations are reasonable; and

WHEREAS, Section 14(B)(5) requires that all charges or fees for a service by Grantee shall be fixed and approved by the Board of Supervisors; and

WHEREAS, a new amendment is necessary to make the annual rate adjustments and updates to exhibit B of the Agreement each year.

NOW THEREFORE, it is agreed as follows:

1. The amended rates as set forth and attached in exhibit B, "Franchise Area Two (2) Rate Adjustments" shall become effective January 1, 2017. Such rates shall supersede and replace all prior rates set forth in the Franchise Area Two (2) Agreement, and all previous amendments to exhibit B thereto, as of the effective date of this Thirteenth Amendment.
2. All other terms and condition of the Agreement remain in full force and effect.
