## AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. PA16-62, BOS16-013 & BOS 16-013-A1

This Amendment to BOS Agreement No. <u>PA16-62</u>, <u>BOS 16-013 & BOS 16-013-A1</u> is entered into this <u>20</u> day of <u>June</u>, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>4Leaf</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, Purchase Agreement No. <u>PA16-62</u> was entered into on <u>January 6th, 2016</u>; and

WHEREAS, Agreement No. <u>BOS 16-013</u> was entered into on <u>April 5th, 2016</u>, to extend the termination date from <u>June 30th, 2016</u> to <u>December 31, 2016</u>; and to increase the "not to exceed" value from \$50,000 to <u>\$150,000</u>; and

WHEREAS, Agreement No. <u>BOS 16-013-A1</u> was entered into on <u>October 18th, 2016</u> to increase the "not to exceed" value from \$150,000 to \$225,000; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>CONTRACTOR</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. <u>PA16-62</u>, <u>BOS 16-013 & BOS 16-013-A1</u>, from <u>December 31, 2016</u> to <u>December 31, 2017</u>; and

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. <u>PA16-62, BOS</u> 16-013 & BOS 16-013-A1 will be extended from <u>December 31, 2016</u> to December 31, 2017.

All other terms and conditions of BOS Agreement No. <u>PA16-62</u>, <u>BOS16-013 & BOS 16-</u>013-A1 shall remain in full force and effect.
