This Amendment to BOS Agreement No. <u>15-100 & 15-100A1</u> is entered into this _____ day of _____, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>NORTHERN CALIFORNIA CONSTRUCTION TRAINING INC.</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 15-100 was entered into on September 22, 2015; and

WHEREAS, BOS Agreement No. <u>15-100A1</u> was amended on <u>March 15, 2016</u> to extend the termination date from September 30, 2016 to December 31, 2016; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and NORTHERN CALIFORNIA CONSTRUCTION TRAINING INC., this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the BOS Agreement No. <u>15-100 & 15-100A1</u>, from <u>December 31, 2016</u> to <u>June 2, 2017</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in the BOS Agreement No. <u>15-100 & 15-100A1</u> from <u>One Hundred Seventy Five Thousand Nine Hundred Nine Dollars and Fifteen Cents (\$175,909.15)</u> to <u>Two Hundred Forty Thousand Four Hundred Ninety Four Dollars and Fifteen Cents (\$240,494.15)</u>.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original BOS Agreements No. <u>15-100 & 15-100A1</u> will be extended from <u>December 31, 2016</u> to <u>June 2, 2017</u>.
- 2. The total contract amount set out in the original BOS Agreements No. <u>15-100 & 15-100A1</u> will be increased from <u>One Hundred Seventy Five Thousand Nine Hundred Nine Dollars and Fifteen Cents (\$175,909.15)</u> to <u>Two Hundred Forty</u>

Thousand Four Hundred Ninety Four Dollars and Fifteen Cents (\$240,494.15).

All other terms and conditions of BOS Agreement No. <u>15-100</u> shall remain in full force and effect.
