AMENDMENT TO PURCHASING AGENT AGREEMENT NO. <u>17-36</u>

This Amendment to PA Agreement No. 17-36 is entered into this 12 day of Sep1, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Liebert Cassidy Whitmore, hereinafter referred to as "CONTRACTOR".

WHEREAS, PA Agreement No. 17-36 was entered into on July 1, 2016; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>Liebert Cassidy Whitmore</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the contract amount set out in the original PA Agreement No. <u>17-36</u>, from <u>\$50,000</u> to <u>\$350,000</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original PA Agreement No. <u>17-36</u>, from <u>June 30</u>, <u>2017</u> to <u>October 31</u>, <u>2017</u>; and

NOW, THEREFORE, we agree as follows:

- 1. The CONTRACTOR shall receive an additional Three Hundred Thousand Dollars (\$300,000.00). The compensation payable for this amendment to Agreement No. PA# 17-36 shall not exceed Three Hundred Fifty Thousand Dollars (\$350,000.00).
- 2. The termination date set out in the original BOS Agreement No. <u>17-36</u> will be extended from <u>June 30, 2017</u> to <u>October 31, 2017</u>.

All other terms and conditions of PA Agreement No. <u>17-36</u> shall remain in full force and effect.
