WHEREAS, funding for a one year extension of services will be \$200,000;

NOW, THEREFORE, we agree as follows:

Term Date: The termination date set out in the original Agreement No. BOS# 12-093 will be extended from July 30, 2017 to July 31, 2018.

Amount of agreement: The amount set out in the original Agreement No. BOS12# - 093 will remain \$200,000 annually.

Expected outcome of amendment: Services will continue without interruption of service.

All other terms and conditions of Contract Agreement No. BOS# 12-093 are to remain in full force and effect.
