Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that County Counsel shall investigate options in repsect to "grandfathering" existing Class K structures, as well as options for hardship exemptions or time extensions.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that a new single family residence shall be limited to 2,000 square feet of habitable space under Class K.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that Wildland Urban Interface (WUI) requirements shall be required for all new single family residences.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that a perimeter foundation, as required by California Building Code (CBC), shall be required under all new single family residences, and all accessory structures greater than one story in height, unless otherwise determined by an engineer.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that the Class K Ordinance shall state that the most recently adopted version of the Uniform Building Code (UBC) would be the operative code. This would avoid the necessity of having to re-adopt Class K each time the UBC was re-adopted.
