Project Description	With the help of engaged stakeholders, Phase 1 of the UVBGSP development project resulted in the formation of the Ukiah Valley Basin Groundwater Sustainability Agency (UVBGSA). Additionally, Phase 1 included the development of an initial data management system; a monitoring network protocol and data gap analysis; preliminary description of the groundwater resources and current undesirable results; a spreadsheet-based water budget and development of MODFLOW-2005 using monitoring data from 2014 to 2017; drafted goals and measurable objectives; and a preliminary list of potential management actions. In the proposed Phase 2 project, preliminary technical work will be finalized through review by the recently formed Technical Advisory Committee (TAC), data gaps will be filled, more extensive outreach and stakeholder engagement will take place, and additional technical and project/program analysis will be performed. Interim work products will be used to support incremental decisions by UVBGSA through committees, ad hoc work groups, and public meetings. Technical analysis will include developing a long-term data management strategy; completing a hydrogeologic conceptual model (HCM); extending the MODFLOW calibration period; applying MODFLOW to develop future baseline without project conditions and climate change scenarios; and applying MODFLOW to evaluate project/program alternatives. Project and program analysis will include developing final sustainability goals and measurable objectives, sustainability indicators and thresholds; reviewing plans, projects, programs, and policies; reviewing groundwater and related resource management measures; configuring, comparing, and selecting alternatives; evaluating the financial/funding landscape; and preparing an implementation plan. A drafted UVBGSP will be provided for public review and comment prior to preparing the final plan.
Project Objective	This project aims to develop and adopt a Ukiah Valley Basin Groundwater Sustainability Plan (UVBGSP), which documents how the UVBGSA and its members will sustainably manage groundwater (GW) and surface water (SW) such that local water rights are protected; the local economy is sustained and can grow; and the Russian River fishery and riparian resources are preserved, while meeting SGMA and DWR requirements, SWRCB orders and decisions, and the biological opinion on related project operations.

Water availability has been an issue, especially after multiple dry years, and it is a likely constraint to future development, complicating the legal, environmental, political, and socioeconomic issues. The UVBGSA will use the UVGBGSP to preserve and enhance the economic and environmental health and well-being for the Ukiah Valley through regional stewardship and comprehensive management of water and groundwater resources in a practical, cost-effective, sustainable and responsible manner. The Phase 2 work plan builds on Phase 1 work conducted under the Department of Water Resources (DWR) Counties with Stressed Basins Grant. Phase 1 work included compiling surface water and groundwater data; preparing a data gap analysis; producing a groundwater monitoring protocol manual; engaging stakeholders; developing an initial hydrogeologic conceptual model (HCM) and water budget; preliminary identification of undesirable results, minimum thresholds, measurable objectives; and an action plan including a list of projects and actions. Proposed Phase 2 work includes stakeholder and community outreach; developing final sustainability goals; completing a hydrogeologic conceptual model; calibrating and applying MODFLOW-2005; addressing water supply and quality needs of disadvantaged communities (DACs); identifying UVBGSP projects, policies, and programs; defining current and future water budgets under the no action and preferred alternative, both with and without climate change; developing a preferred alternative; establishing key

milestones, schedules, and stable funding; integrating water supply and land use plans and programs; preparing the draft and final UVBGSP to provide a roadmap for the region's future over a 50-year planning horizon.
