

## RESOLUTION NO. 19-007

### **RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS APPROVING NOTICE OF COMPLETION AND RELEASE OF CONTRACT SURETY, DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 160044, MENDOCINO VILLAGE PARKING STRIPING ON LANSING STREET, COUNTY ROAD 500, MILEPOST 0.00 TO MILEPOST 0.16 AND MAIN STREET, COUNTY ROAD 407E, MILE POST 0.05 TO 0.36 (MENDOCINO AREA)**

WHEREAS, by Resolution Number (No.) 16-098 adopted August 2, 2016, the Mendocino County Board of Supervisors authorized Department of Transportation (DOT) to advertise and award DOT contract No. 160044; and

WHEREAS, on September 28, 2016, DOT awarded DOT Contract No. 160044 to Chrisp Company of Fremont, California, for Mendocino Village Parking Striping on Lansing Street, County Road 500, Milepost 0.00 to Milepost 0.16 and Main Street, County Road 407E, Milepost 0.05 to Milepost 0.36; and

WHEREAS, final inspection and submission of contract records for the construction activity on the project was made pursuant to the Recommendation for Acceptance and filing of Notice of Completion accompanying this resolution; and

WHEREAS, section 9204 of the California Civil Code provides that a public entity may record a notice of completion on or within 15 days after the date of completion of a work of improvement and section 9200 provides that completion of a work of improvement occurs at the earlier of the acceptance of the work of improvement by the public entity or the cessation of labor on the work of improvement for a continuous period of 60 days; and

WHEREAS, section 9356 of the California Civil Code provides that a stop pavement notice is not effective unless given before the expiration of 30 days after the recordation of a Notice of Completion; and

WHEREAS, section 9558 of the California Civil Code provides that a claimant may commence an action to enforce the liability on a payment bond no later than six months after the period in which a stop payment notice may be given under section 9356 of the Civil Code.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors:

1. Accepts the completed work, approves the form of Notice of Completion and authorizes the Director of Transportation to execute the Notice of Completion for DOT Contract No. 160044 and file it with the County Recorder; and
2. Authorizes and directs the Director of Transportation to release, in accordance with the following schedule, the contract bonds filed by the contractor, Chrisp Company, 43650 Osgood Road, Fremont, CA 94539, pursuant to the provisions of DOT Contract No. 160044 executed October 25, 2016; and

3. Authorizes and directs the Director of Transportation to release, thirty days from the date of recordation of Notice of Completion, upon confirmation with the Clerk of the Board and the Auditor that no claims or lawsuits have been filed against same, the Performance Bond (No. 106600371) in the amount of \$37,830.00 issued by the Travelers Casualty and Surety Company of America, Hartford, CT 06183; and
4. Authorizes and directs the Director of Transportation to release, thirty days plus six months from the date of recordation of Notice of Completion, providing no claims or lawsuits have been filed against same, the Labor and Materials Bond (No. 106600371) in the amount of \$37,830.00 issued by the Travelers Casualty and Surety Company of America, Hartford, CT 06183.
