Mental Health Treatment Act Citizen's Oversight Committee Actions & Recommendations 2019

January 23, 2019:

- Kemper Report accepted as a guideline for the Mental Health Treatment Act Citizen's Oversight Committee to make recommendations to the Board of Supervisors regarding program, priority, and funding.
- Made recommendation to Board of Supervisors to explore utilizing Measure B funds for the development of a Crisis Stabilization Unit (CSU), Crisis Residential Treatment (CRT), and Psychiatric Health Facility (PHF) facility.
- Request that Board of Supervisors direct staff to research options associated with such facility, including design/bid/build and potential property or facility locations.

February 27, 2019:

- To obtain a Project Manager to assist the Mental Health Treatment Act Citizen's Oversight Committee with their goals.
- Advisory Team volunteered to work with County staff on Mental Health Treatment Act Citizen's Oversight Committee issues.

March 27, 2019:

 To form an Ad Hoc Committee consisting of members Jan McGourty, Jed Diamond, Jenine Miller, and Donna Moschetti to review the Kemper Report recommendations, excluding the study of services at this time, with the understanding that the Ad Hoc Committee will not usurp the original recommendations of the Mental Health Treatment Act Citizen's Oversight Committee to move forward with the feasibility study.

Board Direction 2019

January 8, 2019:

 The Board of Supervisors authorized County Counsel to provide legal services to the Mental Health Treatment Act Citizen's Oversight Committee, with condition that County Counsel provides a monthly update to the Board on time the allocated accordingly.

February 5, 2019:

• The Board of Supervisors received the update regarding the recommendations from the Mental Health Treatment Act Citizen's Oversight Committee and directed staff to proceed with researching options associated with the development of Crisis Residential Unit(s), Crisis Stabilization Unit(s), Crisis Treatment Unit(s), and 24 Hour Psychiatric Health Facility utilizing Measure B Funds, including design, bid and/or build potential properties or facilities locations. Said options to be presented to the Board of Supervisors at a future meeting for discussion and/or direction as appropriate.

March 12, 2019:

• The Board of Supervisors adopted a resolution authorizing the adoption of the classification of Administrative Project Manager - Measure B and changes to the Position Allocation Table as follows: Budget Unit 1020, add 1.0 Full-Time Employee (FTE) Administrative Project Manager - Measure B; and authorizes Chair to sign name.

Current Activities

- County staff is drafting an Request for Proposal (RFP)/Request for Qualifications (RFQ) for feasibility study and architectural services regarding Crisis Stabilization Unit (CSU), Crisis Residential Treatment (CRT), and Psychiatric Health Facility (PHF).
- ► Human Resources posted the recruitment for the classification *Administrative Project Manager Measure B*, on March 25, 2019, and will continue the interviewing/hiring process based on the list of applications received.
