

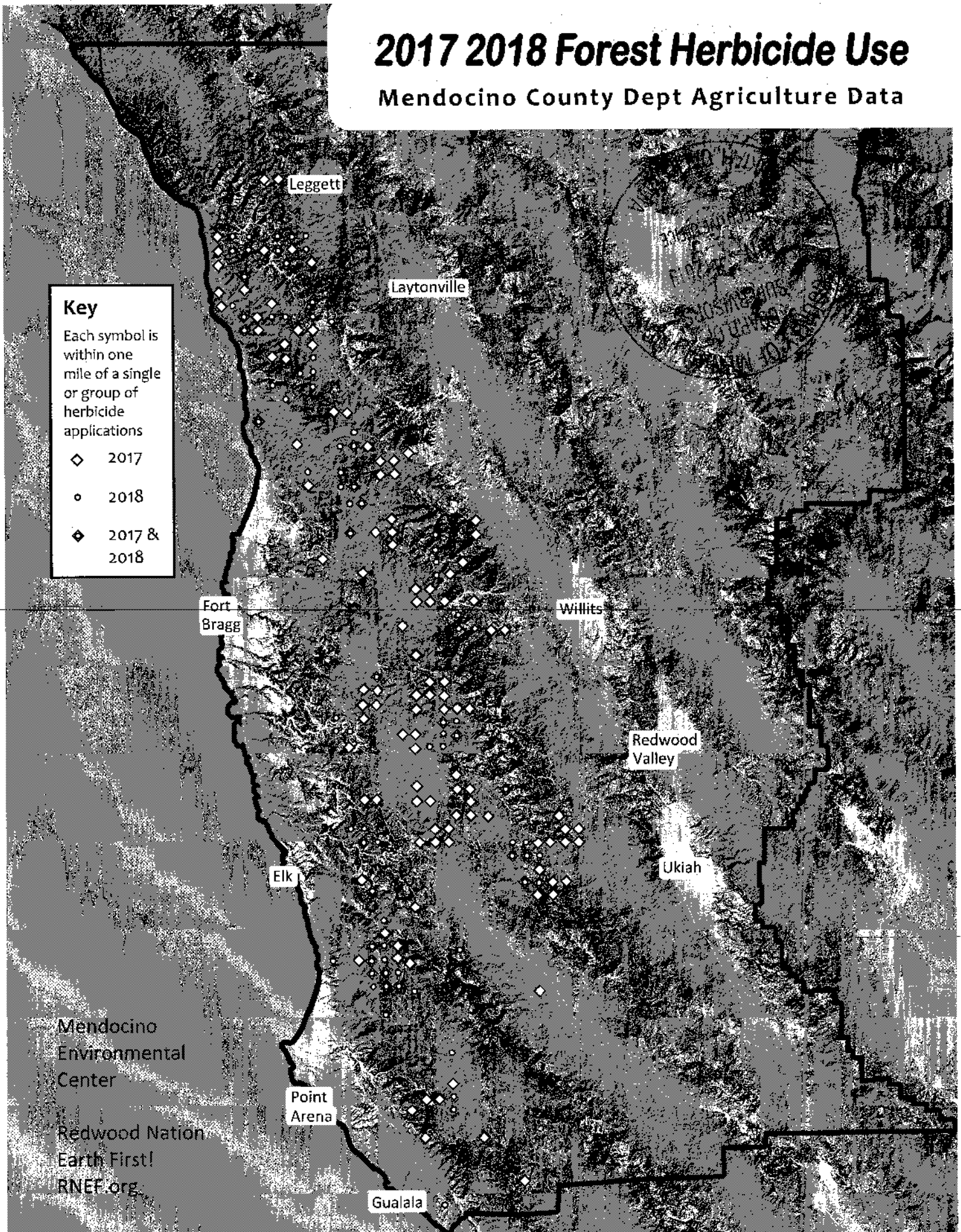

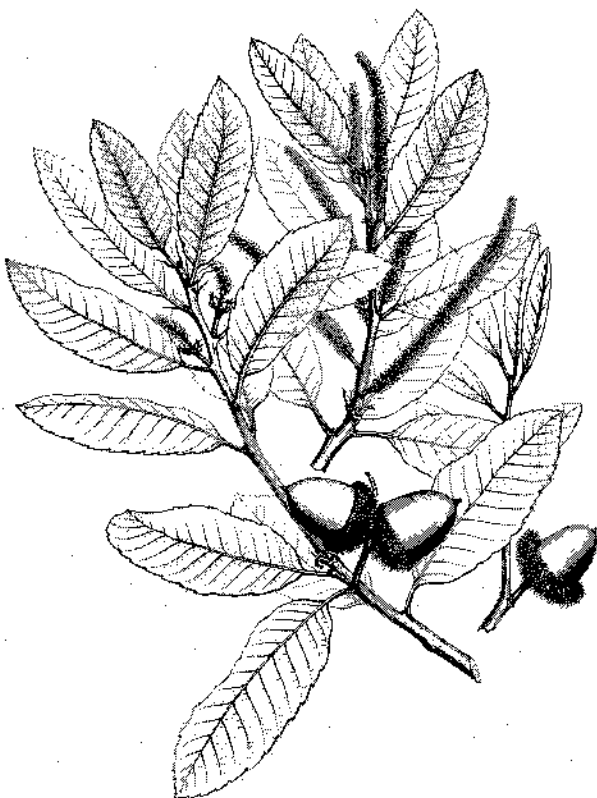

Mendocino County passed Initiative Measure V by a 62% majority in 2016, prohibiting the intentional leaving of dead standing trees. Absent enforcement, pending clarification of the Ordinance requested by County Supervisors from the State Attorney General in 2016, timber companies have continued using herbicides to kill trees and brush. Mendocino Redwood Company is by far the largest user, applying Imazapyr and Glyphosate primarily on tanoaks across 109,593 acres of Mendocino County over the past 18 years.
