- **2017 Storm Damage Repairs on Blue Lake Terrance, County Road (CR) 671, at Milepost (MP) 0.50, Federal Emergency Management Agency (FEMA) Repair Project Construction Contract:** Pursuant to Board Resolution Number (No.) 18-088 (June 19, 2018), bids for Department of Transportation (DOT) Contract No. 170084, 2017 Storm Damage Repairs on Blue Lake Terrance, CR 671, at M.P. 0.50 were opened as scheduled on Thursday, June 13, 2019. Gene Wixson Enterprises, Inc., of Willits, California, was deemed the apparent "low bidder" for this project with a bid of \$69,045.00. The Engineer's Estimate for the contract was \$87,400.00.

- **2017 Storm Damage Repairs on Fish Rock Road, CR 122, at MP 19.10, FEMA Repair Project Construction Contract:** Pursuant to Board Resolution No. 18-088 (June 19, 2018), bids for DOT Contract No. 190013, 2017 Storm Damage Repairs on Fish Rock Road, CR 122, at MP 19.10, were opened as scheduled on Thursday, June 13, 2019. Gregg Simpson Trucking, of Ukiah, California, was deemed the apparent "low bidder" for this project with a bid of \$109,217.50. The Engineer's Estimate for the contract was \$97,300.00.

- **Storage and Custody of Historical Surveyor Records:** MCDOT currently possesses various survey records from private land surveyors. Over several decades, these records have been placed in the custody of MCDOT through various means for the purpose of allowing public access to them. Many of them have been donated by family members of deceased surveyors as an alternative to disposing of them due to their historical value. These documents are not official County records and are seldom accessed by members of the public, however, are historically significant.

The storage of these records has become quite costly and burdensome as MCDOT must currently lease space to store other official records due to the amount of space these non-County records occupy in the County building. MCDOT is pleased that the Mendocino County Historical Society has agreed to become the custodian of the surveyor records and continue to make them available to the public. Arrangements are currently being made to have the records moved to their new home at the Mendocino County Historical Society's archival building.
