**DESCRIPTION**

This project will design and construct a new stand alone building adjacent to the existing county jail located on county owned land. The building will provide a new housing unit with programming and treatment space, and a new public visiting center. The new housing unit will include approximately 60 rated beds; a safety cell; respiratory isolation cell; recreation yards; housing unit control; nursing station; medical exam room; dental exam room; program/group rooms and staff support space. The new public visiting center will include contact and non-contact visiting rooms for families and attorneys. The project will include, but is not limited to; electrical; plumbing; mechanical; heating; ventilation, and air conditioning; security; site improvements; fire protection systems; security fencing and all other necessary appurtenances.
