

Special Needs Housing Unit



- The building is 21,000 Sq. Ft.
- There are 60 beds, expandable to 90 beds
- Housing severely mentally ill, serious medical problems, special needs males and maximum security females
- **JBCT Program**
- Therapeutic programing and counseling

Project Funding

State Reimbursement: \$25,000,000.

County Match to Date: \$2,047,804.

Budgeted Match 2019-20: \$500,000

Total Project Funding: \$27,547,804.



Design Development Budget June 2019

Hard Costs: \$21,767,368

Soft Costs: \$5,780,436

Total Project: \$27,547,804



Project Cost Reductions:

- Reduce structural and building shell costs
- Lower roof height
- Identify alternate resources for program needs
- Streamline security system delivery
- Reduce landscaping and site lighting
- Identify bid alternates including building reduction
- Separate Offsite Improvements from Building Project




Cost Savings From Offsite Improvement Project

- Reduce Jail Project duration
- Eliminate project phase to move Facilities and Fleet parking
- Simplify Jail Project
- Modify fleet operations and traffic flow before project start
- Estimate \$300,000 from Jail Expansion Project budget
- Already funded from county match
- Will still exceed county match minimum



OFFSITE IMPROVEMENT PROJECT



Construction Management Contract:

- RFP Issued February 2019
- One Proposal Received Vanir Construction Management
- Construction Manager is the County's partner in Cost Control
- Award amount \$1,509,698 not to exceed contract
- Exceeds Original Estimate of \$1,116,700
- Does not exceed overall budget with other reductions
- Included as Soft Cost in Project Budget
