

**AMENDMENT TO PURCHASING AGENT
AGREEMENT NO. 18-253**

This Amendment to Purchasing Agent Agreement No. 18-253 is entered into this 9th day of April, 2019, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Liebert Cassidy Whitmore (LCW), hereinafter referred to as "CONTRACTOR".

WHEREAS, Purchasing Agent Agreement No. 18-253 was entered into on September 19, 2018; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Liebert Cassidy Whitmore (LCW), this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the amount payable to Contractor set out in the original Purchasing Agent Agreement No. 18-253, from \$50,000 to \$110,000; and to extend the termination date from June 30, 2019 to December 31, 2019.

NOW, THEREFORE, we agree as follows:

1. The amount payable set out in the original Purchasing Agent Agreement No. 18-253 will be extended from \$50,000 to \$110,000.
2. The termination date set out in the original Purchasing Agent Agreement No. 18-253 will be extended from June 30, 2019 to December 31, 2019.

All other terms and conditions of Purchasing Agent Agreement No. 18-253 shall remain in full force and effect.
