

**AMENDMENT TO PURCHASING AGENT
AGREEMENT NO. 20-32**

This Amendment to Purchasing Agent Agreement No. 20-32 is entered into this 1st day of October, 2019, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and THOMAS LAW GROUP, hereinafter referred to as "CONTRACTOR".

WHEREAS, Purchasing Agent Agreement No. 20-32 was entered into on July 26, 2019; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and THOMAS LAW GROUP, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total amount payable to CONTRACTOR in the original Purchasing Agent Agreement No. 20-32, from \$50,000 to \$125,000.

NOW, THEREFORE, we agree as follows:

1. The total amount payable to CONTRACTOR shall be increased from \$50,000 to \$125,000.

All other terms and conditions of Purchasing Agent Agreement No. 20-32 shall remain in full force and effect.
