RE: Williams Settlement Annual Report to Mendocino County Board of Supervisors

Dear Supervisor Brown,

Pursuant to Education Code 1240, I am officially notifying the County Board of Supervisors of my findings regarding site visits for Decile 1-3 schools in Mendocino County. As you know, the ACLU filed a class action suit against the State of California which indicated that the state had failed to provide poor and underprivileged students with equal educational opportunities (AKA: *Williams Settlement*). The specific elements of the lawsuit included inadequate school facilities, insufficient educational materials, and a lack of fully-credentialed teachers.

I am pleased to inform you that in August, September and October of 2019, the MCOE *Williams* Site Review Team conducted another year of visits to school sites. Each site visit was a positive and professional experience, characterized by a collaborative focus on improving student achievement to ensure equal educational opportunities for all children in Mendocino County.

General Statistics

Of the 12 school districts in Mendocino County, eight districts have one or more Decile 1-3 schools in their district. The County Superintendent of Schools or a designee(s) visited all 15 of the Decile 1-3 schools to review instructional materials, facilities, quarterly uniform complaint reports, and teacher misassignments and vacancies.

Teacher Misassignments & Vacancies

During the 2018-2019 school year, there were four teachers (one at Eagle Peak Middle School, and three at Pomolita Middle School who lacked the appropriate authorization for their assignment. All assignments were rectified by reassignment, retirement, or applications for appropriate credentials within 30 calendar days. 2019-2020 teacher misassignments and vacancies are monitored throughout the year and will be summarized in next year's letter to the Board of Supervisors.

Instructional Materials Insufficiencies

The instructional materials section of the *Williams* Settlement is the most difficult and complicated of the review process. With the 2019-2020 site visits completed this fall and I am pleased to inform you that all of the Williams Monitored Schools successfully proved sufficient materials within the first eight weeks of school for the 2019-20 school year with the exception of Arena Union Elementary.

Anderson Valley Elementary - Anderson Valley Unified School District

Inspected on September 12, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

Arena Union Elementary - Arena Union/Pt. Arena Joint Union

Inspected on August 30, 2019 and found insufficient for materials in Social Science for first grade for the 2019-20 school year. Because the Arena Union Elementary School Board has not adopted Studies Weekly, these instructional materials cannot be counted as part of Williams. There are currently not enough books of the older curriculum, Scott Foresman, to be sufficient. Per discussion with the principal, the adoption process has begun and is currently in the committee and public viewing stage and the books should be adopted within the next three months. After board adoption, the completed meeting minutes must be forwarded to MCOE to be proven sufficient for the 2019-20 school year.

Point Arena High School - Arena Union/Pt. Arena Joint Union

Inspected on September 13, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

Dana Gray Elementary - Fort Braga Unified School District

Inspected on August 29, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

<u>Laytonville Elementary – Laytonville Unified School District</u>

Inspected on September 16, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

Round Valley Elementary – Round Valley Unified School District

Inspected on September 12, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

<u>Calpella Elementary - Ukiah Unified School District</u>

Inspected on September 4, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

Eagle Peak Middle School - Ukiah Unified School District

Inspected on September 12, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

<u>Grace Hudson Elementary - Ukiah Unified School District</u>

Inspected on August 30, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

Nokomis School - Ukiah Unified School District

Inspected on September 10, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

Oak Manor Elementary - Ukiah Unified School District

Inspected on September 12, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

Pomolita Middle School - Ukiah Unified School District

Inspected on September 3, 2019 and successfully proved sufficient in materials for the 2019-20 school year.

Baechtel Grove Middle School - Willits Unified School District

Inspected on August 30, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

Blosser Lane Elementary - Willits Unified School District

Inspected on September 6, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

Willits High School - Willits Unified School District

Inspected on September 6, 2019 and successfully proven sufficient in materials for the 2019-20 school year.

Facilities Review

As a result of the site reviews, it was determined that the majority of Mendocino County Schools are in overall good repair. There were no findings from the 15 site visits that qualified as one of the "eight emergency repair situations that poses an emergency or urgent threat to the health and safety of students or staff." Of the fifteen schools, one received an "exemplary" rating, nine received a "good" rating, four received a "fair" rating and one received a "poor" rating. A list of findings for each school is included in this report. All districts have received a copy of the Superintendent's findings.

School Ratings: 99%-100% = Exemplary	Note: An extreme deficiency in any area

Exemplary: The school meets most or all standards of good repair. Deficiencies noted, if any, are not significant and/or impact a very small area of the school.

Good: The school is maintained in good repair with a number of non-critical deficiencies noted. These deficiencies are isolated, and/or resulting from minor wear and tear, and/or in the process of being mitigated.

Fair: The school is not in good repair. Some deficiencies noted are critical and/or widespread. Repairs and/or additional maintenance are necessary in several areas of the school site.

Poor: The school facilities are in poor condition. Deficiencies of various degrees have been noted throughout the site. Major repairs and maintenance are necessary throughout the campus

Many WC ramps have trip hazards that could have serious consequences for WC users. New trim paint on main building and interior paint in some classrooms are nice upgrades. Have noticed improvements each year.

Quarterly Uniform Complaints

Quarterly, MCOE receives uniform complaint forms from each of the twelve Mendocino County School Districts. The quarterly reports indicate if any complaints have been filed at the district office in the areas of textbooks and instructional materials, teacher vacancy or misassignments, facilities and California High School Exit Exam (CAHSEE) Intensive Instruction and Services and the LCAP (Local Control Accountability Plan). During the 2018-2019 academic year, there were no *Williams* complaints filed with any of the districts in the county.

SARC (School Accountability Report Card)

The SARCs for all 15 schools were monitored for the accuracy of two *Williams* Settlement components included on the report card, *sufficiency of instructional materials* and *status of school facilities*. Inaccuracies noted were reported on the third quarter report to the district superintendents.
