## **RESOLUTION NO. 19-390**

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS APPROVING AN INCREASE OF THE MENDOCINO SOLID WASTE MANAGEMENT AUTHORITY SURCHARGE FEE FROM \$5.00 PER TON TO \$6.50 PER TON AND AUTHORIZING THE CHIEF EXECUTIVE OFFICER OR HIS OR HER DESIGNEE, TO REVIEW AND APPROVE ANY REQUESTS FOR PASS-THROUGH RATE ADJUSTMENTS THAT MAY RESULT FROM THE SURCHARGE FEE INCREASE PURSUANT TO THE TERMS OF THE RELEVANT SOLID WASTE FRANCHISE AGREEMENT (COUNTY-WIDE)

WHEREAS, The Mendocino Solid Waste Management Authority (MSWMA) is a joint powers agency (JPA) organized in 1990 by the County of Mendocino, City of Ukiah, City of Fort Bragg and the City of Willits; and

WHEREAS, MSWMA works with local haulers to ensure trash, recycling, and composting services are being provided to the public according to State and Federal law while also being cost-effective and convenient; and

WHEREAS, the citizens of Mendocino County depend on MSWMA for many household hazardous waste disposal services as well as illegal dump cleanup services which protect health and safety in our communities; and

WHEREAS, MSWMA is funded approximately 50% by grants that are subject to fluctuations and 50% by a surcharge fee - tipping fee on solid waste tonnage delivered to destination landfills; and

WHEREAS, the MSWMA budget lacks the necessary revenues at the current \$5.00 per ton surcharge fee to provide its services and additional revenues are required to balance the budget; and

WHEREAS, in accordance with Section 9(e) of the Amended and Restated Joint Powers Agreement creating MSWMA, it is appropriate and necessary that the Board of Supervisors now join with all other member agencies in authorizing a \$1.50 per ton increase to a total \$6.50 per ton surcharge fee; and

WHEREAS, the Board of Supervisors acknowledges that the increase in the surcharge fee will generally increase solid waste disposal rates of member agency customers by an estimated 2% to 4%, depending on service location, as solid waste franchise agreements generally allow for such fees to be passed through to consumers.

NOW, THEREFORE, BE IT RESOLVED by the Mendocino County Board of Supervisors as follows:

- 1. The Board of Supervisors hereby approves an increase in the MSWMA JPA surcharge fee by \$1.50 per ton to \$6.50 per ton; and
- 2. Authorizes the Mendocino County Chief Executive Officer, or Director of Transportation if designated by the Chief Executive Officer, to review and approve any requests for pass-through rate adjustments that may result from the surcharge fee increase pursuant to the terms of the relevant solid waste franchise agreement.
