Traffic Study Number 19-11: SPEED ZONE STUDY ON FORT BRAGG SHERWOOD ROAD, COUNTY ROAD 419, EAST OF ITS INTERSECTION WITH FORT BRAGG CITY LIMITS (FORT BRAGG AREA)

BACKGROUND

In response to a petition from the residents along Fort Bragg Sherwood Road, County Road (CR) 419, Traffic Study Number (No.) 19-11, an Engineering and Traffic Study for speed zoning, was undertaken on Fort Bragg Sherwood Road, CR 419, at mile post (MP) 0.40, in November of 2019. The section of road has not been justified by an engineering and traffic study (E&TS) within the last five years and therefore it is subject to the State's 55 miles per hour (MPH) maximum speed law: "The maximum speed limit per California Vehicle Code 2015, section 22349. (a) Except as provided in Section 22356, no person may drive a vehicle upon a highway at a speed greater than 65 miles per hour. (b) Notwithstanding any other provision of law, no person may drive a vehicle upon a two-lane, undivided highway at a speed greater than 55 miles per hour..."

The petitioners seek to have the County of Mendocino Department of Transportation decrease the speed limit in conformance with the California Manual of Uniform Traffic Control Devices (CA MUTCD) requirements.

For prima facie speed limits to be legally enforceable on any road with a functional classification other than local road, the California Vehicle Code (CVC) requires that they must be:

- 1. Determined on the basis of an Engineering and Traffic Survey, (E&TS); and
- 2. Adopted by Ordinance; and
- 3. Posted

Failure to meet any one of the three of the preceding requirements will result in the creation of an unenforceable speed trap as defined by the CVC. Section 627 of the CVC further requires that an ET&S shall include consideration of the following:

- 1. Prevailing speeds determined by traffic engineering measurements
- 2. Collision records
- 3. Highway, traffic, and roadside conditions not readily apparent to the driver

Unless conditions not readily apparent to the driver are found to exist and are properly documented, the CA MUTCD requires that the speed limit, unless otherwise warranted, shall be established at the 5 MPH increment closest to the prevailing (85th percentile) speed.



Prevailing Speed

During November 2019, a radar speed survey was performed on Fort Bragg Sherwood Road, CR 419, where seven days of free-flowing traffic were encountered and measured. Results of this Traffic Study are presented below in Table 1. A detailed survey may be found in Appendix A.

Collision Records

The County's database for Fort Bragg Sherwood Road, CR 419, extends back to 1999. There have been 55 accidents on this road in the past 21 years. Of these 55 accidents, 27 of them occurred within the studied area, from MP 0.00 to MP 1.75. A detailed summary of all reported accidents on Fort Bragg Sherwood Road, CR 419, may be found in Appendix B.

Unapparent Conditions

The presence of conditions not readily apparent to the driver would be evidenced in the collision records or in recurring damage to roadside features. This road has high number of number of accidents, many of which are related to the curvy nature of the road in combination with the narrow roads with a narrow shoulder.

ANALYSIS

The western end of Fort Bragg Sherwood Road, CR 419, which begins at Fort Bragg city limits, is a series of tight turns with limited visibility, descending and ascending moderate grades. From just east of Fort Bragg city limits to Marsben Lane, there are approximately 23 driveways encroaching on this half mile stretch of Fort Bragg Sherwood Road, CR 419. However, most of the homes are setback more than 75 feet from the roadway. Currently, Fort Bragg Sherwood Road, CR 419, has a non-enforceable posted speed limit of 40 MPH. There are no roadside conditions that are not readily apparent to the driver. No portion of this road qualifies as a residential district under Sections 515 and 240 of the CVC. The petitioners seek to have the County post an enforceable speed limit in the vicinity of their homes, (the

area Fort Bragg City Limits and Mile Post 1.75, approximately 1 ¾ of a mile). Exhibit A in Appendix C illustrates a pictorial representation of the speed zone study area.

Mendocino County Code Sec. 15.04.040 governs speed limit changes and charges the County Road Commissioner with determining an application meritorious. Typically, the Road Commissioner's decision as to merit is based on many factors including but not limited to majority of community support (citizen petition), support of public safety agencies (California Highway Patrol – CHP), meeting the CA MUTCD and Caltrans Traffic Manual Policies and Warrants for establishing speed limits. Based on information collected on a recent radar speed survey, traffic volumes on Forty Bragg Sherwood Road, CR 419, are high, calculated to be in the range of 1,086 vehicles per day and with volumes not exceeding 100 vehicles per hour. CA MUTCD and Caltrans Traffic Manual Policies and Warrants for where to establish speed limits would indicate that this 1 ¾ mile section of road merits a speed zone. Thus, the County Road Commissioner will, in light of practical enforcement considerations and due to the high volume of vehicles and accidents, finds this Speed Zone Change application meritorious and direct that this speed zone engineering study be prepared and submitted per CVC requirements.

The 85th percentile speed was found to be 43 MPH in both directions; this is to be rounded to 40 MPH per the CA MUTCD to establish a valid, enforceable speed zone per the CVC requirements. Per the Section 2B.13 (12a) of the CA MUTCD, "When a speed limit is to be posted, it shall be established at the nearest 5 mph increment of the 85th percentile speed of free-flowing traffic, except... [f] or cases in which the nearest 5 mph increment of the 85th percentile speed would require a rounding up, then the speed limit may be rounded down to the nearest 5 mph increment below the 85th percentile speed, if no further reduction if used". In this case, given the high number of accidents and the narrow roads, the rounding down is valid.

Drivers are influenced more by the appearance of the roadway itself and the prevailing conditions than by the posted speed limit. National research confirms what has been observed in Mendocino County, which is that lowering or raising speed limits has no predictable effect on actual travel speeds; they remain essentially unchanged. The only effect on traffic of establishing a prima facie speed limit is to enable patrol officers to use radar speed enforcement.

RECOMMENDATION

Under Mendocino County Code Section 15.04.040 the Road Commissioner has found this speed zone change request meritorious for this one and three quarter mile stretch of Fort Bragg Sherwood Road, CR 419. Refer to Exhibit B in Appendix C which demonstrates the proposed 85th percentile speed zone is valid per CVC.
