

RESOLUTION NO. 20-045

**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING THE DIRECTOR OF TRANSPORTATION TO CLOSE POWERHOUSE ROAD (CR 248A) AT THE WILLIAMS CREEK BRIDGE FOR THE DURATION OF CONSTRUCTION ACTIVITIES ESTIMATED FROM JUNE 15 TO DECEMBER 4, 2020, PURSUANT TO SECTIONS 942.5 AND 942.6 OF THE CALIFORNIA STREETS AND HIGHWAYS CODE (POTTER VALLEY AREA)**

WHEREAS, a closure of Powerhouse Road is necessary to replace the Williams Creek bridge in place; and

WHEREAS, under Sections 942.5 and 942.6 of the California Streets and Highways Code, the Board of Supervisors (BOS) may authorize the Director of Transportation to close roads subject to certain limitations set forth in State law; and

WHEREAS, road closure for construction will last for approximately 120 working days estimated to start on June 15, 2020 and end on December 4, 2020; and

WHEREAS, the necessity of road closure was presented in the CEQA documents approved by the BOS on July 11, 2017 under BOS Resolution Number 17-097; and

WHEREAS, road closure was included in the public workshop held on March 23, 2016, with no objections raised by the public or Potter Valley Fire Department representatives; and

WHEREAS, emergency vehicles and other traffic may easily detour to the other side of the bridge.


NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors authorizes the Director of Transportation to close the use of Powerhouse Road (CR 248A) at Williams Creek for the duration of construction activities estimated from June 15, 2020, through December 4, 2020, pursuant to Sections 942.5 and 942.6 of the California Streets and Highways Code.

The foregoing Resolution introduced by Supervisor Brown, seconded by Supervisor Williams, and carried this 20<sup>th</sup> day of April, 2020, by the following vote:
