

**SECOND AMENDMENT TO COUNTY OF MENDOCINO
STANDARD SERVICES AGREEMENT NO. SS-19-029**

This second Amendment to Agreement No. SS-19-029 is entered into this 5th day of May, 2020, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **Deaf Counseling Advocacy and Referral DBA Communique Interpreting**, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. SS-19-029 was entered into on July 1, 2019; and

WHEREAS, Amendment No. SS-19-029-A1 was entered into on September 4, 2019; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the amount set out in original Agreement No. SS-19-029, from \$10,000 to \$27,000.

NOW, THEREFORE, we agree as follows:

1. The amount set out in original Agreement No. SS-19-029 will be increased from \$10,000 to \$27,000.

All other terms and conditions of Agreement No. SS-19-029 shall remain in full force and effect.
