It is reasonable to understand there is an issue with those involved in profiting from the suffering of others. I will therefore give you my opinion on their problem! This obvious and absurd, vicious favoratism for animal cruelty is shocking!

In Regards to Wildlife Services,

Poor leadership and bad decisions made by this, consistently cause pain and suffering in the world! It is necessary to support a non- lethal wildlife management program!

The name wildlife services is wrong since I don't see them serving wildlife, but those who destroy it for personal gain.

Ranchers, who are the primary benefactors of the wildlife services decision for cruel, and lethal management cause the public an estimated \$123 billion annually, in meat related illnesses. Yet my tax dollars are given to them through subsidy's that are required to benefit the public! However the products (which were once living, breathing, feeling individuals) produced by ranchers, are not a benefit at all but instead cause public disease!

Heart disease, cancer, diabetes, arthritis, obesity, human mad cow disease, swine flu, avian bird flu, pharmaceutical failures, and a myriad of other health related problems are the direct result of administrative decisions that negatively affect society and cause further pain and suffering to animals, the environment, and humans alike!

Then further atrocities are committed through product and pharmaceutical testing to treat the diseases caused by ranchers and the wrongful decisions made by bad leadership!

Identified in the Macdonald triad, displaced anger can result in animal torture. A disproportionate number of serial killers, exhibit one, two, or all three of the Macdonald triad for predictors of future violent behavior.

They are involved in sadistic activity, especially in children who have not reached sexual maturity, this activity may take the form of torturing animals - and the decision made by wildlife services for further cruelty to animals is promoting it!

Serial killing often begins due to family and a lust driven cruelty that is originally seen toward animals.

A child may suffer from a fractured personality as a result of parental misguidance, cruelty, abuse, and the legality of animal torture. Most serial killers are originally reported as having been overly sensitive before witnessing cruelty to animals, drove them to murderous acts.

The fracture is defined as a small breakage of the personality which is often not visible to the outside world and is only felt by the killer.

Frequently resulting in sociopathic behavior in which people are seen as good members of society, but behind the scenes engage in atrocities towards animals, humans, and the environment!

Some of this includes, Mission Oriented- those justifying their killings as a means of 'ridding the world' of certainundesirables, or unwanted individuals.

Which is the reason for the lethal decision by wildlife 'services'.

Power and Control:in which the main objective is to gain and exert power over their victims.

Humans can legally do this to animals.

And Hedonistic killings which include the 3 categories of Thrill, Lust and Comfort.

These serial killers are driven by profit and a pleasure that comes from sadism, which is the enjoyment of seeing suffering in others!

Certainly a pleasure hunters and trappers take, and then force also upon the younger generation!

Sadism is common in thrill kills often motivated by the "ideal victim type" who has certain physical characteristics.

In this case such as being 'only an animal'.

They seek the adrenaline rush provided by hunting and killing their victims.

Thrill killers murder for the thrill of the kill and we all know that's what hunting especially in children is for. The enjoyment of it, not the physical need.

Not the necessity of it! This is what we face in the case of USDA Wildlife Services for managing interaction with predators and other wildlife.

An alternate is available to the current brutal methods being used. They can choose to support instead a science based nonlethal alternative wildlife program. Which is expected of them from the public in general. As we see cruelty as being unnecessary particularly in the face of a legitimate and humane alternative! Which is available right now.

Hedonistic Comfort killing: material gain and a comfortable lifestyle are the primary motives of comfort killers.

Which of course is another motivation behind the animal slayings!

Necrophilia is a pathological fascination with dead bodies.

Classifications pertaining to hunters and trappers and those who support this by law, do not involve intercourse with the corpse, but merely a stimulation felt in the presence of a dead body.

Stimulation is derived under the following categories:

Tactile necrophiliacs: people who are aroused by touching or stroking a corpse, without engaging in intercourse.

Fetishistic necrophiliacs:people who derive pleasure from removing body parts from a corpse with out engaging in intercourse.

And Necromutilomaniacs: people who derive pleasure from mutilating a corpse, without engaging in intercourse.

All of this is done by hunters and trappers as a form of pleasure and stimulation, and should not be encouraged or upheld by law, particularly in this case where an alternative to these activities is currently available!

Forcing this on a child, especially who is unwilling to go hunting with their family and family's friends I believe are victims of pedophilia, since the parents sexual orientations are geared towards gratification and stimulation with a corpse. The parents insistence, and abusive tactics (often psychological, physical, and /or emotional) can cause reaction formation in the child transforming their fear into desire!

Because this is spread to children they can suffer a break in reality resulting in a decline in society as a whole!
