RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING THE MENDOCINO COUNTY HEALTH AND HUMAN SERVICES AGENCY DIRECTOR OR DESIGNEE TO SIGN AGREEMENT NUMBER 20-10099 AS AN AGENT ON BEHALF OF THE COUNTY OF MENDOCINO FOR THE AIDS DRUG ASSISTANCE PROGRAM WITH THE CALIFORNIA DEPARTMENT OF PUBLIC HEALTH

WHEREAS, the Board of Supervisors of the County of Mendocino (hereafter "Board") has read the proposed Agreement between California Department of Public Health (hereafter "CDPH") and the Mendocino County Health and Human Services Agency, Public Health (hereafter "Public Health"), Agreement Number 20-10099 (hereafter "Agreement"); and

WHEREAS, the Board acknowledges the benefits and responsibilities to be shared by both parties to said Agreement; and

WHEREAS, CDPH, Center for Infectious Diseases, Office of AIDS is the lead agency within the state responsible for coordinating state programs, services and activities related to Human Immunodeficiency Virus (HIV) and Acquired Immunodeficiency Syndrome (AIDS); and

WHEREAS, the AIDS Drug Assistance Program Branch administers both the AIDS Drug Assistance Program for people living with HIV and AIDS in California, and the Pre-Exposure Prophylaxis Assistance Program for HIV negative individuals for the prevention of HIV; and

WHEREAS, Public Health will provide enrollment sites at the three Public Health locations in Mendocino County to provide AIDS Drug Assistance Program and Pre-Exposure Prophylaxis Assistance Program enrollment services.






