# Meeting the Challenge for a New Senior Community Center

Bartlett Hall Opened for Seniors in 1977 and No Longer Meets the Increasing Needs of Local Seniors

- > Too Small to Accommodate Current Events and Activities
  - 166 Maximum Seating Capacity Is Insufficient
  - Inadequate Parking for Seniors and Guests
- Lack of Energy Efficiency and Renewable Energy Options
- > Too Costly to Maintain or Modernize For Current Needs

New Senior Community Center Will Benefit Mendocino County and other Community Partners

- Ukiah Senior Center and Rural Communities Housing Development Working to Co-Locate New Community Center and Low Income Senior Housing

- Larger Community Center Accommodates Events and Activities for Other Nonprofit Organizations Who Use Ukiah Senior Center's Facilities

- River Oak Charter School Seeks to Expand Using Old Ukiah Senior Center Community Hall and Thrift Store Facilities and expanded parking

Opportunity for New Senior Community Center to Co-Locate on 2.5 acres at the east end of the RCHDC Parcel








Corner of Orchard Avenue & Brush Street




- Within Mendocino County's Jurisdiction

#### **Site Considerations:**

- Existing City of Ukiah Well Site
- RCHDC Use Permit Requirements
- Minimum Parking Requirements
- Traffic Flow for USC Bus Access
- 2.5 Acres of Developable Space
  - Community Center and Administration Offices
  - Thrift Store Facility

Feasibility Study completed in 2016 confirmed suitability for new senior community center at this site.



#### Community Center Building – 17,000 sq.ft.

- Auditorium and Lobby 6,800 SQ FT
  - o 254 Dining / 400-500 Assembly Seating
  - Elevated Stage
  - 1,500 Sq Ft Lobby Area
- Commercial Kitchen/ Offices 3,150 SQ FT
  - 3,000 Sq Ft Commercial Kitchen
  - 150 Sq Ft Office
- Office Facilities 5,800 SQ FT
  - Lunch Bunch Activity Room [Lower Level]
  - Transportation Dispatch Office [Lower Level]
  - Outreach Services Office [Lower Level]
  - Administration Offices & Meeting Rooms [Upper Level]

#### Thrift Store Building - 5,850 SQ FT

- 4,000 SQ FT Retail Space
- 1,000 SQ FT Warehouse/Sorting
- 850 SQ FT Indoor/Outdoor Covered Patio



### Community Center Design Considerations

- Increase Seating
   Capacity to 254
- Add Lobby Area with Covered Drop-off
- Improve Access to Lunch Bunch,
   Outreach and Transportation
- Increase Parking

- Larger Facility Expands Services to More Seniors
- Increases Proximity for Senior Housing Residents to Senior Programs, Meals, Activities and Services

#### Revenue Projections

#### **Ukiah Senior Center Thrift Store**

By expanding retail space from 1,100 sq.ft. to 5,000 sq.ft., USC will become self-sustaining through increased annual sales revenue. Additional sales tax revenues will also benefit Mendocino County.





### New Community Center Venue and Commercial Kitchen

The New Community Resource Center will expand event opportunities for area seniors and multiple nonprofit community partners, while providing rental income for future sustainability.

State and Federal grants and loans are sought through support from and collaboration with Mendocino County.

### **Next Steps**

- Ukiah Senior Center seeks authorization for limited staff support from Mendocino County to prioritize and pursue Community Development Block Grant funds and other available government grants or loan opportunities
- Ukiah Senior Center will initiate a Capital Building Fund Campaign for community benefactors' support
- Ukiah Senior will pursue purchase of Brush Street parcel from Rural Communities Housing Development Corp.
- Ukiah Senior Center will pursue sale of existing Leslie St. property to River Oak Charter School for its expansion
- Ukiah Senior Center will pursue commercial construction loan financing opportunities through the Savings Bank

The Ukiah Senior Center is grateful for Mendocino County's ongoing support through annual service contracts that enable local seniors to maintain their independence and self-reliance each year.


