- 1 Install two new Mitsubishi MUZ-JP12WAU1 12,000 BTU mini split heat pump cooling systems in IDF room as noted. Install by Reliance Enterprises
- 2 Install roof mount outdoor units. Install by Reliance Enterprises.
- 3 Provide lead/lag control for the two units.
- Install two separate 220v 20A circuits to roof top units, with service disconnect switches at each unit. A service 120v outlet will also be installed at roof top location Watertight roof penetrations approved by county will be provided. Electrical circuits will come from new sub-panel included in RFP 2.
- Relocate existing 5 gal. electric water heater to attic area. Install 3/4" plywood platform 5 above location next to attic access. Remove existing vent pipe and waterlines in IDF room as needed. Extend and reconnect waterlines and 220v 30A electrical supply to new water heater location. Install Unistrut at new location and water heater seismic strap kit. Install drain pan beneath water heater tank and route to existing floor drain in janitor closet. Patch drywall ceiling as needed.


