This third Amendment to Agreement No. PH-19-081, PA No. 20-128 is entered into this <u>22**</u> day of <u>September</u>, 2020, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **Wild Fish**, hereinafter referred to as "CONTRACTOR".

WHEREAS, original Agreement No. PH-19-081, PA No. 20-128 was entered into on May 26, 2020; and

WHEREAS, the first Amendment, BOS Agreement No. 20-107, was entered into on July 14, 2020; and

WHEREAS, the second Amendment, BOS Agreement No. 20-107-A1, was entered into on August 18, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the second Amendment, BOS Agreement No. 20-107-A1, from September 9, 2020 to December 31, 2020; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the amount set out in the second Amendment, BOS Agreement No. 20-107-A1, from \$314,500 to \$454,500; and

WHEREAS, it is the desire of the CONTRACTOR and COUNTY to alter the number of participants and meals served by CONTRACTOR.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the second Amendment, BOS Agreement No. 20-107-A1, will be extended from September 9, 2020 to December 31, 2020.
- 2. The amount set out in the second Amendment, BOS Agreement No. 20-107-A1, will be increased from \$314,500 to \$454,500.
- 3. CONTRACTOR will serve approximately two hundred four (204) meals to approximately sixty-eight (68) eligible program participants in Anderson Valley and the Coastal Areas of Mendocino County.

All other terms and conditions of original Agreement No. PH-19-081, PA No. 20-128,

first Amendment, BOS Agreement No. 20-107, and second Amendment, BOS Agreement No. 20-107-A1 shall remain in full force and effect.
