The new bridge would be similar in character to the existing bridge, namely a single-span, steel truss structure. In addition to the new bridge, an approximately 200-foot section of the eastern roadway approach and 300 feet of the western approach to the bridge would be improved with two 10-foot wide travel lanes with 2-foot wide shoulders to accommodate the new bridge deck elevation, width and location. Construction is expected to begin in summer 2024.
