

Petition to the Mendocino County Board of Supervisors

Please sign this petition to stop AT&T/Epic Wireless LLC from building a 143 ft. wireless communication facility 5.1± miles southeast of the City of Willits, on Pine Mountain.

We, the Neighbors and Friends of Pine Mountain, Willits, petition the Mendocino Board of Supervisors to **deny the Major Use Permit U_2019-0011**, per our appeal dated June 12, 2020.

- Due to the cumulative impacts that cannot be properly addressed in a Negative Declaration, the many environmental issues, weak conditions of approval and meaningless mitigations, **this project needs an Environmental Impact Report.**
- The **site is in a very high fire hazard zone** of dying Pine trees. A potentially volatile situation is created by seasonal high afternoon winds, a generator, diesel fuel storage, electrical equipment and antenna towers that attract lightning.
- Facility **site access roads aren't adequate to ensure public safety** transport in an emergency.
- The flawed Negative Declaration **did not contain a biological and botanical field survey**, which is needed prior to commencement of any activities that may modify vegetation (clearing, mowing or ground-breaking)
- This **facility would have a negative effect on people, animals and plants living in close proximity** to this electromagnetic and microwave structure.
- This communication facility **will have a significant negative effect on property values.**
- There have been **no safety studies done by the industry that prove this technology is safe, and thousands of studies which show it is indeed unsafe.**
- Communication plans for Mendocino County **must expand use of underground fiber-optic cables.**

Mendocino County signed its Precautionary Principle Policy in 2006, which states:

“There is a duty to take anticipatory action to prevent harm.”

The statements below are excerpted from the 6-4-20, **Resolution of the Planning Commission, County of Mendocino, option to deny the use permit U_2019-0011b application in Pine Mountain:**

“Given the proximity (580± ft) of the proposed project to the more densely populated residential neighborhood and the elevation drawings submitted by the applicant..., a 143 foot lattice type wireless communication facility would dominate the surrounding tree line and is out of character with the established surroundings. ...The proposed project would be partially visible to surroundings properties and nearly directly in line with the height of surrounding residential parcels. Given these aesthetic and topographic concerns, the proposed tower is out of character with the surrounding neighborhood and its rural setting and conflicts with...” Mendocino County’s Wireless guidelines, adopted 8-4-2015. It will not “protect and promote...the aesthetic quality of the county”.

Mendocino County Code Section 20.196.020(C) “Contrary to this requirement, the proposed use would be considered detrimental to the health, safety, peace, morals, comfort of general welfare of persons residing or working in or passing through the neighborhood of such proposed use, or be detrimental or injurious to property and improvements in the neighborhood...”
