AMENDMENT TO STANDARD AGREEMENT NO. PH-19-080, PA No. 20-126 AND FIRST AMENDMENT BOARD OF SUPERVISORS AGREEMENT NO. 20-075

This second Amendment to Agreement No. PH-19-080, PA No. 20-126 is entered into this _______, day of ________, 2020, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **Cucina Verona**, hereinafter referred to as "CONTRACTOR".

WHEREAS, original Agreement No. PH-19-080, PA No. 20-126 was entered into on May 12, 2020; and

WHEREAS, first Amendment BOS Agreement No. 20-075 was entered into on June 10, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original Agreement No. PH-19-080, PA No. 20-126 and first Amendment BOS Agreement No. 20-075, from June 10, 2020 to August 9, 2020; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the amount set out in first Amendment BOS Agreement No. 20-075 from \$249,500 to \$554,500; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the number of participants and meals served and update the Exhibit A, Definition of Services, to include additional meals.

NOW, THEREFORE, we agree as follows:

- 1. **Term Date**: The termination date set out in the original Agreement No. PH-19-080, PA No. 20-126 and first Amendment BOS Agreement No. 20-075 will be extended from June 10, 2020 to August 9, 2020.
- 2. **Amount**: The amount set out in first Amendment BOS Agreement No. 20-075 will be increased from \$249,500 to \$554,500.
- 3. **Exhibit A**: The Exhibit A, Definition of Services, set out in original Agreement No. PH-19-080, PA No. 20-126 has been altered and a new Exhibit A is attached herein.

All other terms and conditions of original Agreement No. PH-19-080, PA No. 20-126 and first Amendment BOS Agreement No. 20-075 shall remain in full force and effect.

EXHIBIT A

DEFINITION OF SERVICES

- A. CONTRACTOR shall provide the following services:
 - 1) Prepare and deliver nutritionally appropriate and balanced meals for the Great Plates Delivered Program.
 - 2) Provide approximately two hundred sixty-six (266) meals per day to approximately ninety-nine (99) eligible program participants in the City of Fort Bragg, CA and surrounding areas. Participants will be identified by COUNTY. CONTRACTOR may not add or delete program participants without COUNTY's prior approval.
 - 3) Provide a maximum of three (3) meals per day, per program participant.
 - 4) Provide meals that adhere to the following guidelines:
 - a) Breakfast low in sodium, no sugary drinks (<24 calories /8 oz. and of fruit juice, must be only 100 percent fruit juice allowed); and
 - b) Lunch and dinner a piece of fresh fruit or vegetable on each dish, and low in sodium, no sugary drinks (<24 calories /8 oz. and of fruit juice, must be only 100 percent fruit juice allowed).
 - 5) Source local produce when applicable.
 - 6) Prepare meals within Mendocino County.
- B. Individuals providing delivery of meals, regardless if they are volunteers or employees, must complete a background check through the COUNTY to ensure safety of participants.
- C. CONTRACTOR should currently not be participating in a state or federal meal service program.
