

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. BOS 18-132**

This Amendment to BOS Agreement No. 18-132 is entered into this 20th day of Oct., 2020, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and COMMUNITY DEVELOPMENT SERVICES (CDS), hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 18-132 was entered into on 9/1/2018; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Community Development Services (CDS), this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. 18-132, from 08/30/2020 to 08/30/2022; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total compensation set out in the original BOS Agreement No. 18-132, from \$250,000 to \$500,000; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to include providing loan servicing for three (3) county business loans at \$75.00 per loan, per month into the SCOPE OF WORK set out in the original BOS Agreement No. 18-132.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. 18-132 will be extended from 08/30/2020 to 08/30/2022.
2. The total compensation amount set out in the original BOS Agreement No. 18-132 will be increased from \$250,000 to \$500,000.
3. The SCOPE OF WORK set out in the original BOS Agreement No. 18-132 will include loan servicing for three (3) county business loans at \$75.00 per loan, per month.

All other terms and conditions of BOS Agreement No. 18-132 shall remain in full force and effect.
