RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS RATIFYING ORDINANCE NO. 20-1, AMENDING "FIRE SAFETY ORDINANCE" OF THE HOPLAND FIRE PROTECTION DISTRICT TO ADOPT, BY REFERENCE, AND AMEND SELECTED PROVISIONS, CHAPTERS, AND APPENDICES OF THE CALIFORNIA CODE OF REGULATIONS, TITLE 24, 2019 EDITION OF THE CALIFORNIA FIRE CODE, TO ADOPT LOCAL FINDINGS, AND TO MAKE TECHNICAL AND ADMINISTRATIVE REVISIONS TO THE FIRE SAFETY ORDINANCE

WHEREAS, no ordinance adopted by the Hopland Fire Protection District shall be effective until ratification by the County where the ordinance will apply; and

WHEREAS, upon ratification of the adopted ordinance, the County shall file a copy of the findings of the district, and any findings of the County, together with the adopted ordinance expressly marked and identified to which each finding refers, with the Department of Housing and Community Development.

NOW THEREFORE BE IT RESOLVED that the Mendocino County Board of Supervisors does hereby ratify Ordinance No. 20-1 of the Hopland Fire Protection District amending "Fire Safety Ordinance" to adopt, by reference, and amend selected provisions, chapters, and appendices of the California Code of Regulations, Title 24, 2019 Edition of the California Fire Code, to adopt local findings, and to make technical and administrative revisions to the fire safety ordinance.

BE IT FURTHER RESOLVED that enforcement of this ordinance is delegated to the Hopland Fire Protection District.
