This Ordinance amends section 14.32.030 of the Mendocino County Code to prohibit camping on the public right-of-way on Geysers Road between mile post 0.00 and mile post 0.64. This Ordinance also amends section 15.12.040 of the Mendocino County Code to prohibit parking on the same portion of Geysers Road between the hours of 10:00 p.m. and 6:00 a.m., and to prohibit parking on the southerly side of Vichy Springs Road from the intersection of Watson Road to the easterly end of the bridge over the Russian River, between mile post 0.30 and mile post 0.35. This Ordinance also amends section 15.12.041 of the Mendocino County Code to limit parking to no longer than twenty minutes on both sides of First Street in Hopland west from U.S. Highway 101 to Center Street and a cleanup change to move the limited time parking restriction on Basin Street from section 15.12.040 to section 15.12.041 Limited Time Parking.
