Focused Resume' of Norman L. de Vall to Fill the Vacancy on the Mendocino Coast Healthcare District Board of Directors

Objective: To be appointed to the Mendocino Coast Healthcare District Board of Directors.

As a resident of the Mendocino Coast since 1962, I have been keenly aware of the need for adequate health care for coastal residents. By the early '70's the two coastal hospitals located in Fort Bragg were replaced with the formation of the Mendocino Coast Hospital District. I joined with other community members to establish the Hospital District and the building of our then new medical facility.

In 1974 supported by both physicians and staff, I ran for the Board of Directors advocating support for SEIU representation of our staff. While not winning that election, we were successful in getting union representation for our employees.

During my years on the Board of Supervisors (1979-1995), Hillside Hospital, General Hospital and Mendocino County Community Hospital closed. The Board of Supervisors sat as the Board of Directors of the County Community Hospital. As chair or member of the Health & Welfare standing committee I attended numerous staff meetings of the administration and managerial staff.

The coast district hospital is under lease to Adventist Health for thirty years, but the District is under state order to rebuild within the next ten. Determining that future and raising the \$80,000,000 to \$100,000,000 * for that purpose remains the challenge of the District Board of Directors.

At this time there are two vacant seats on the Board. One candidate has filed the needed paperwork and will be on the November ballot; the other seat awaits appointment.

I am asking the Board of Supervisors to consider me for appointment to that seat.
