WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>VISION SERVICE PLAN</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. <u>17-158</u> as amended with Standard Services Agreement No. <u>HI 19-04</u> and Standard Services Agreement No. <u>HI 20-001</u>, from <u>December 31, 2020</u> to <u>December 31, 2023</u>; and

WHEREAS, the original BOS Agreement No. <u>17-158</u> as amended with Standard Services Agreement No. <u>HI 19-04</u> and Standard Services Agreement No. <u>HI 20-001</u> is increased in the amount of One Hundred Sixty Seven Thousand, Nine Hundred Sixty Four Dollars (\$167,964) for employee vision insurance benefits to be provided in calendar years 2021 through 2023, for a total Agreement amount of \$435,134.

NOW, THEREFORE, we agree as follows:

- The termination date set out in the original BOS Agreement No. <u>17-158</u> as amended with Standard Services Agreement No. <u>HI 19-04</u> and Standard Services Agreement No. <u>HI 20-001</u> will be extended from <u>December 31, 2020</u> to <u>December 31, 2023</u>.
