

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 20-145**

This Amendment to BOS Agreement No. 20-145 is entered into this 23RD day of FEB, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Brokaw Design, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 20-145 was entered into on October 21, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Brokaw Design, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the contract amount set out in the original BOS Agreement No. 20-145, from a shall not exceed fifty two thousand seven hundred (\$52,700) to fifty nine thousand five hundred and eighty (\$59,580); and

NOW, THEREFORE, we agree as follows:

1. The compensation payable to CONTRACTOR in the original BOS Agreement No. 20-145 will be increased from shall not exceed fifty two thousand seven hundred (\$52,700) to fifty nine thousand five hundred and eighty (\$59,580);

All other terms and conditions of BOS Agreement No. 20-145 shall remain in full force and effect.
