

## RESOLUTION NO. 21-028

### RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AMENDING THE POSITION ALLOCATION TABLE PROVIDING THE NUMBER AND COMPENSATION OF OFFICERS, DEPUTIES AND EMPLOYEES IN THE VARIOUS OFFICES OF THE COUNTY OF MENDOCINO

WHEREAS, the Board of Supervisors has adopted Resolution No. 20-079 which sets forth the classifications, salaries, and number of personnel in the various County departments; and

WHEREAS, it is the wish and desire of the Board of Supervisors to amend said resolution to meet the needs of County service; and

WHEREAS, the affected departments or agencies have agreed to incorporate the positions within their existing fiscal year budgets; and

WHEREAS, Human Resources has determined that due to the direct / indirect reporting to the Chief Executive Officer and assignment within the Executive Office, the classifications listed below should be classified as at-will and unrepresented (exempt from Civil Service and bargaining representation); and

WHEREAS, the allocation of four full time equivalent (4.0 FTE) positions to Budget Unit 2910 Disaster Recovery, in the below classifications is pursuant to the Board's adoption of Proposed Allocation Adjustments approved during the FY2020-21 Mid-Year Budget presentation.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby adopts the below classifications and authorizes the Position Allocation Table of said Resolution to be amended accordingly:
