Progress Report: Oct 2019-March 2020

Activities Overview for Reporting Period:

Oct. 1, 2019 to March 31, 2020

Description of Accomplishments, Benefits and Impacts Attributed to Project and its Activities:

Initial data has been gathered by the Economic Development and Financing Corporation (EDFC) who reviewed 11 economic indicators and interviewed more than 15 key business owners, industry leaders, and stakeholders. We have secured the hire of Economic Development Coordinator, Una Wirkebau to project manage the ongoing workplan. A steering committee was established, with regular reoccurring meetings, comprised of economic development stakeholders and county. To date the committee has:

- Created a project plan
- Created and launched website www.MOVE2030.org
- Created <u>www.facebook.com/move2030 site</u>
- Data compilation has begun with a completed SWOT analyses report
- Determined Cluster analyses conducted by 3rd part vendor is in progress

Reviews and discussions on regional economic development plans in adjacent communities (Humboldt County, Lake County, Windsor, Sonoma County, Eureka, Arcata, Healdsburg). EDFC has contacted all 4 cities, initiating input and responses to survey questions for data collection.

In progress, development of an advisory team with key leaders to begin meeting in June

Discussion of Challenges that Current Impact or Could Impact Project Progress:

• COVID-19 and the associated Shelter-in-Place ruling is causing some difficulty in contacting various entities for data collection

• Unable to have a community kick-off for event, due to Shelter-in-Place directive

Discussion of Needs for EDA Assistance or Information that Should be Known to EDA:

- Adjustments have been made to the Digital Learning Hub Scope of Work. It has been approved and we are awaiting the paperwork for final sign off
- The *Mendocino County Digital Infrastructure Plan: 2019 2025* managed by the North Bay North Coast Broadband Consortium (NBNCBC) has submitted the application to the CPUC's CASF Infrastructure Program for grant funding to implement the first part of the plan for broadband expansion
