Dear Commissioners,

Mendocino County property owners are not aware or being informed that grading, rocking agriculture land, and removing native vegetation without an assessment of these impacts is not permissible in the county. There is a bulldoze first, permit later approach and the County is silent.

Will the planning commission receive new cannabis applications where significant alterations and conversions have occurred and accept them?

Currently, heavy equipment is rapidly destroying countless habitats including prime agriculture land and the County is not advising folks otherwise. Landowners do not even realize these development action could be an impediment to their future licensing and approval, or will they?

What steps are in place to inform the public that they should not grade, rock or remove vegetation before taking the appropriate review steps. If those steps do not exist, why are we expanding licensing? Starting next week, I suggest applicants should not be able to get a license if they have graded and rocked rangeland or an agriculture field, rather they should have to remediate their grading and vegetation removal if they did not get properly reviewed. Otherwise, the submission of an application is giving cover for a variety of significant environmental impacts to continue.

I strongly oppose expanding cannabis permitting until our County understands impacts and adjusts ordinances as needed to reflect a logical process to ensuring cannabis farms are not having an impact. Study first, receive a permit, and then proceed with a conversions.

What does the public want? I believe grading and rocking associated with the construction of greenhouses and the aesthetic impacts of these structures should be limited to select areas with conditional approvals that address the conversion aspect as well as plastic waste and light impact.

It would seem more work is need drafting ordinances that guide the land use objectives of our community, such as requiring more cannabis to be grown outdoors to minimize impacts. When will we let landowners know that developments, with environmental impacts, that occur before review and approval, will result in a denied permit and ideally remediation requirements.


I am writing to address the upcoming decision about cannabis expansion, I live in the north county where we are already experiencing negative impacts from the large corporate grows that have taken over not only the industry but our valley also.


The increase in traffic to the large grows have resulted in road and bridge damage from water trucks. So much roadside garbage from out of the area workers that have no sense of pride for our rural area. The garbage is alcohol bottols, cans and to go food containers. I personally pick up bags of garbage weekly.

As we go into another drought year we are concerned for our water sources. In my town Laytonville at least two neighborhoods have had water in long time wells diminished by Henrys Original corporate grows, and their water grab, with no concern for neighborhood impacts. On Mulligan Rd subdivision they have had multiple wells run low on water. I recently learned from a former Henrys Original employee that they also ran their well dry next door to me at another of their grows. This is from a conversation I was having with the former employee discussing the Mather Ln well they had at the Henrys large grow.



In the cannabis ordinance the supervisors never put in language to protect neighbors. Nothing addresses the small one lane private dirt roads. We residents have struggled for years to maintain our private one lane dirt roads. The large corporate grows have done nothing to maintain or repair shared roads. At my location they ruined our small private wooden bridge. With numerous way too heavy water trucks. Our only access for our neighborhood, in and out, is so bad we cannot get fire trucks or larger PG&E truck, that we needed during the week long power outage, over the bridge. Code enforcement, BOS, Sheriff dept, B&P, CHP have ALL refused to take action addressing the problem. Why are the rural private residents left with no protections from the damage from large (absentee owners) corporate greed weed operators.





Our community as a whole does not want our water diplited, our roads torn up, garbage strewn along our roads Lots of transient residents where there is no housing. Next door to me there is a trailer encampment with no septic and sketchy electric and an assortment of unknown people, Henrys employees.

This is not the time to recommend expansion. Until protections for our shared water supply, roads, bridges are addressed, it is bad for this county.

The small grow cannabis farmers have worked long and hard to create legislation that honors the environment, the laws and the economy of MENDOCINO County. To relegate decision making solely to the Planning department staff is, at best, flouting the democratic process. If they are responsible for all of the decisions of where, how much, and under what conditions to allow cannabis growing it will eliminate the following protections that exist in the current ordinance.

- * The prohibition on new operations in the County's Rangeland Zone.
- * The cap on the size of the grow sites of 10,000 sq. ft. per permit
- * The 2-permits-per-parcel limitation
- * The protections against tree removal
- * The generator phase-out timeline
- * The protections against light pollution.

Instead of strengthening our ordinance, this new proposal will eliminate all of these protections and it will allow for a massive expansion of the size and number of cannabis grows in the county, including large commercial grows through a Use Permit process. Use Permits are issued for a minimum of 10 years with indefinite renewals and accompany the property regardless of the owner. Historically Use Permits in this county are rarely, if ever, monitored by county staff.

Of particular concern is the provision that would open all of our Rangelands to development, and allow up to 10% of a parcel 10 acres or more in the Ag, Upland Residential, and Rangeland zones to be converted to cannabis. For example, a 160-acre parcel could have sixteen acres of cannabis. That would be destructive to the small family grower, and it will not be environmentally sustainable.

The **Farm Bureau does not support** this new proposal, the **small cannabis grower does not support** it, **our Sheriff does not support it**, and the **environmental community does not support it**. And this new proposal is NOT the Vision supported by the majority of citizens of this county, as evidenced by the fact that Measure AF, which proposed cannabis in almost every zoning district, went down to defeat in 2016.

This proposal wholly ignores the recommendations of the Mendocino Climate Action Committee regarding appropriate land use development to meet the need for greenhouse gas reduction and carbon sequestration goals.

It also ignores the goals of our new federal administration which is calling for 30% of our lands to be set aside to try to stem the collapse of our wildlife population from climate change. If we were to continue preserving our Rangelands we would be able to meet that 30% goal.

If we hope to have even a semblance of a salmon fishery again we will have to have cool running streams and rivers. Not the hot, shallow, and algae-choked rivers we are seeing now across our county. Our water has already been over-allocated if we hope to meet the challenges of climate change in the years ahead, and unfortunately, cannabis likes a lot of water and a lot of fertilizer.

Also, there is no proposed funding for a remedy to the abject failure of the citizen-driven complaint system of enforcement that we have now. The county does not have the budget, the staff, or the track record to responsibly invite a big expansion of cannabis operations at this time.

A change of this scale should be broadly and openly discussed with the community, not sprung on the public and even some board members over the course of a weekend - making a mockery of our local democracy. And considering the magnitude of the expansion plan, the county, at the very least, should do a full Environmental Impact Review (EIR).

I'm writing to express my opposition to the Commercial Cannabis Activity Land Use Ordinance for the following reasons:

- 1) The proposed ordinance eliminates hard-won protections for small growers and the environment which are part of the existing Cannabis Cultivation Ordinance. (See above.)
- 2) The proposed ordinance opens the door for massive expansion of cannabis cultivation in the county and thus creates powerful incentives for large-scale commercial and residential development throughout the county's remote, rural, environmentally sensitive landscape. This will add to the multitude of known and unknown impacts already affecting the county's human and natural environments.
- 3) The county does not have the budget, the staff or the track record to responsibly invite new cannabis operations at this time. The Board's primary responsibility now is to follow through on its obligations to current permittees, and to the taxpayers; to show that the county is capable of completing permit applications, and eliminating and cleaning up the hundreds of non-compliant, illegal operations.

- 4) The proposed ordinance, though promulgated as a solution to the present debacle, fails to remedy the spectacular failure of a citizen-driven complaint system of enforcement. It neither proposes or funds an alternative enforcement plan while blindly inviting more and larger operations into every remote, hidden, hard-to-access corner of the county.
- 5) The proposed ordinance wholly ignores the recommendations of the Mendocino County Climate Action Committee regarding the implications of land use development and the need to meet greenhouse gas reduction and carbon sequestration goals. It ignores the committee's recommendation NOT to open the rangeland zones to new commercial development. The proposed ordinance actually creates incentives for dispersed residential and remote rural commercial development which in turn would increase vehicle miles travelled for every aspect of new residential and commercial operations, and increase demands on fire fighters, among other things. In contrast, the existing ordinance prohibits new commercial cannabis development in the more remote undeveloped wildfire-prone areas of the county and instead directs new cannabis businesses to locate in zones already impacted by development, or where water and public services, including fire protection, are more readily available.
- 6) The proposed new ordinance abandons the hard-won protections of the existing ordinance that would apply to both existing and new growers, specifically: no new cultivation in the rangeland zone; 10,000 sq. ft. caps on cultivation size; a limit of two permits per parcel; tree removal prohibitions; a generator use phase-out timeline; prohibition on any light pollution leaving a property; a detailed and specific watershed analysis for new operations, and others.
- 7) The new ordinance was never discussed openly and broadly in public forums around the county but, rather, was sprung on the public, and even on some members of the Board of Supervisors, over the course of a weekend! It is a disgrace and a failure of our democratic process.
- 8) In contrast, the existing ordinance, IF ENFORCED, supports the vision shared by a majority of county residents small scale, high quality, outdoor-grown cannabis, and NOT just another boom-and-bust exploitive industry that leaves its wreckage across the county.

To the Planning Commissioners:

I wholly oppose the proposed Commercial Cannabis Activity Land Use Ordinance. As a Mendocino County resident (Yorkville) I know first hand the negative impact of cannabis growing on neighborhoods and roads. I am surrounded by grows, both permitted and non-, which were not here when I purchased the property. The current law has allowed commercial operations into rural residential areas and the result has been a decline in road conditions, ongoing noise and light, fire risk, and a significant change to an established sense of community (aside from being noisy, the growers separate themselves, are often drugged out when interacting, litter and leave feces by in the road, smoke in the dry grass in the middle of the summer, and have a tendency to be belligerent – the worst offenders being from the permitted grow). I absolutely do not support any expansion of cannabis growing, certainly until the current laws are effectively managed and neighbors have effective input into which commercial operations are introduced into their area, and an effective means to raise concerns.

Regarding the proposed Ordinance, I am concerned about the loss of current protections, including:

- The prohibition on new operations in the County's Rangeland Zone
- The cap on the size of the grow sites of 10,000 sq. ft. per permit
- The 2-permits-per-parcel limitation
- The protections against tree removal

- The generator phase-out timeline
- The protections against light pollution

I fail to understand the value of this law to County residents. As a resident, I have only experienced negative first-hand impact from cannabis.

I urge you not to pass this ordinance.

Re: Opposition to expansion of cannabis cultivation to 10% of parcel size within the Round Valley Area.

Dear Commissioners,

On behalf of the Covelo Community Services District (CCSD) the Board of Directors are sending this letter to strongly oppose the proposed expansion of cannabis cultivation to ten percent (10%) of parcel size for Agricultural, Rangeland, and Upland Residential zonings. Our oppositions are multi-fold including concerns for public, water, and land health.

We believe that streamlining the current cannabis permitting process is the priority to encourage greater compliance before any expansions. Further, any cannabis expansion is best developed by those working in the permitting departments, not the Supervisors. The information from the permitting Director, its departments, and the Sheriff are to inform the Supervisors as to the best timing, scale, and details of expanding cannabis cultivation.

Our community is plagued with unprecedented criminal activity on a daily basis. This activity is notably related to the proliferation of cannabis cultivation in its current forms. To allow increased cultivation further jeopardizes the health and safety of the valley's residents. Our Sheriff's department is currently unable to effectively maintain the safety needs of the valley and to add an additional burden on them is simply unconscionable.

CCSD currently has a moratorium on new service connections to any developments due to unprecedented levels of Biological Oxygen/Chemical Demands (BOD) in our influent. Our Board, staff, and the public have been

working to address the causes related to this moratorium. Through water testing and their analyses, we have concluded the most likely source of this BOD is from cannabis processing. Allowing cultivation expansions would further impact our ability to safely treat wastewater and foster the much-needed increase in housing and business development in Covelo.

We invite you to tour our valley to witness firsthand the aforementioned issues related to cannabis cultivation. There is an unending amount of illegally dumped trash and at a scale not ever witness before. The land here is at further risk of increased, severe, environmental damage with the proposed expansion of cannabis cultivation.

Finally, a largely overlooked issue with the proposed expansion is the lack of any environmental review or oversight of any kind. The proposal to expand an already resource taxing industry in areas such as our where current drought conditions appear to be limiting the groundwater recharge is irresponsible. It is impossible to adhere to the due diligence sworn to those in public service in this matter without requiring and completing an Environmental Impact Report before any decision is made to this proposal. Such a report would need to include at a minimum: geomorphological models as well as longitudinal monitoring studies of groundwater capacities and limits. By requiring such studies there's greater assurance that all the residents of Round Valley will continue to have adequate access to the water below their homes, businesses, and land.

Please note that each of these noted, serious concerns are echoed by other local public agencies and members of the public.
