RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 200098 TO PERFORM A 2021 CORRECTIVE/PREVENTATIVE MAINTENANCE PROJECT ON ORR SPRINGS ROAD AT AN ESTIMATED COST OF \$4,000,000 (UKIAH AREA)

WHEREAS, the Mendocino County Department of Transportation (DOT) is desirous of providing road maintenance by applying a Full Depth Reclamation followed by a Double Chip Seal wearing course on Orr Springs Road, County Road (CR) 223 between Milepost (M.P.) 24.25 and MP 37.11; and

WHEREAS, the estimated up to \$4 million cost of the 2021 Corrective/Preventative Maintenance Project on Orr Springs Road is anticipated to be paid 100% by available Road Maintenance and Rehabilitation Account (RMRA) funds; and

WHEREAS, this project will be completed to provide the maintenance required to improve and extend the usefulness of our roads; and

WHEREAS, funding to accommodate construction costs is available in Budget Unit 3041 for Fiscal Year (FY) 2020/21 and FY 2021/22; and

WHEREAS, construction costs including the bid additives are estimated to be some \$3,000,000 to \$4,000,000, and will be performed depending on the availability of additional funds; and

WHEREAS, The Director of Transportation believes it is prudent to authorize the Director to award the contract up to \$4 million, depending on available funding; and

WHEREAS, the Director of Transportation recommends proceeding with advertisement for bids.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

1. Authorizes the Director of Transportation to sign the Notice to Bidders inviting I	oids for
DOT Contract No. 200098, the 2021 Corrective/Preventative Maintenance Project	on Orr
Springs Road, CR 223, between M.P. 24.25 and M.P. 37.11; and
