RE: ADOPTION OF RESOLUTION AUTHORIZING THE DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD THE DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 210021 FOR THE SEISMIC RETROFIT OF BRIDGE NUMBER 10C0034 ON EUREKA HILL ROAD OVER THE GARCIA RIVER, COUNTY ROAD 505, MILEPOST 4.92, AT AN ESTIMATED COST OF \$1,556,500 (POINT ARENA AREA)

Honorable Board Members:

The Mendocino County Department of Transportation (DOT) Contract Number (No.) 210021 will provide for the seismic retrofit of Bridge No. 10C0034 on Eureka Hill Road over the Garcia River, County Road 505, milepost 4.92. This project is for the seismic retrofit of the existing concrete and steel bridge with one lane closure.

A general contractor will be required to complete this project at an estimated cost of \$1,556,500, including contingency. The project is to be funded primarily through the Federal Highway Administration (FHWA) Highway Bridge Program (HBP), with the local match funded through the Local Bridge Seismic Retrofit Account.


DOT has received authorization for construction from FHWA and is ready to advertise. Construction is anticipated to begin in the summer of 2021.

I recommend and request that the Board authorize and direct the Director of Transportation to advertise for construction bids and award DOT Contract No. 210021 to provide for the seismic retrofit of Bridge No. 10C0034 on Eureka Hill Road over the Garcia River.

DOT staff personnel have prepared a draft Resolution which provides said authorization for the Board's consideration and adoption.
